**MOTION FOR CONTINUANCE**

AT&T<sup>1</sup> respectfully requests the Commission to continue the prehearing conference currently scheduled for August 5, 2015,<sup>2</sup> in order to give the parties more time to resolve the matter and to work with Commission Staff (who was ordered to file a report with the Commission on August 4) in its investigation of the Complaint.

Counsel for AT&T has conferred with Ms. Smith-Sattarin and Whitney Payne, counsel for Commission Staff, and both have agreed to this continuance. Counsel for AT&T has been authorized to represent that based on the parties' schedules other commitments, the best time for rescheduling the pre-hearing conference would be during the week of September 14<sup>th</sup>.




