## NOTICE OF DISMISSAL

Issue Date: December 24, 2019

On July 24, 2019,¹ the Staff of the Missouri Public Service Commission ("Staff") filed a Complaint against Aimex Communications, Inc. (Company). The Complaint alleged the Company had not filed its 2018 Annual Report and not paid its fiscal year 2019 assessment. On July 25, the Commission issued its Notice of Contested Case and Order Directing Filing. On December 23, the Staff filed a Motion to Dismiss, stating the Company had filed a request with the Commission to cancel its certificate of service (CCN) and accompanying tariff to provide interexchange telecommunication service in Missouri and stating the Commission had granted the requests and canceled the CCN and tariff on September 11.

Commission Rule 20 CSR 4240-2.116(1) states a party may dismiss a complaint without an order of the Commission before prepared testimony or oral evidence has been offered. The parties have not offered prepared testimony or oral evidence. The Commission, therefore, will take notice of the dismissal. This case shall be closed.
