On May 6, 2021, the Commission directed that Socket Telecom, LLC, and Embarq Missouri, Inc. d/b/a CenturyLink file a status report regarding their negotiations no later than July 1, 2021. On July 1, 2021, Socket, with the consent of Embarq and the Staff of the Commission, requested the status report due date be deferred to August 1, 2021. Socket indicated that the parties have made progress in resolving their differences and expect to know whether a final financial settlement can be made by August 1, 2021. The Commission will grant the request to defer the status report due date.

**THE COMMISSION ORDERS THAT:**

1. The *Consent Motion to Defer Status Report Due Date* is granted.
2. Socket and Embarq shall jointly or separately file a status report no later than August 1, 2021.
3. This order shall be effective when issued.
