The accompanying tariff sheets issued by Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or the Company), are being transmitted for filing as a revision of Schedule No. 2, Schedule of Rates for Gas Service:

These tariff sheets are being issued February 21, 2014 to become effective on and after March 7, 2014.

These revised sheets include changes to Company's Purchased Gas Adjustment (PGA) Clause as approved by the Commission. These revisions reflect adjustments to the Regular Purchased Gas Adjustment (RPGA).

The changes in the PGA factors applicable to the Company's service areas, excluding the Rolla area, will increase from 65.00 ¢/Ccf to 71.00 ¢/Ccf. The interruptible sales customers' PGA factor will increase from 45.21 ¢/Ccf to 49.17 ¢/Ccf. The transportation PGA will remain unchanged at 0.00 ¢/Ccf.

The changes in the PGA factors applicable to the Company's Rolla system (Rolla, Salem, and Owensville) service area will increase from 65.00¢/Ccf to 71.00¢/Ccf. The interruptible sales customers' PGA factor will increase from 46.46¢/Ccf to 50.42¢/Ccf. The transportation PGA factor will remain unchanged at 0.00¢/Ccf.

We are enclosing workpapers supporting this filing with the copy of this filing being provided to the Staff. Certain of the work papers have been designated "Highly Confidential" since they contain market specific information directly relating to the natural gas markets where Ameren Missouri must compete for its gas supplies. The Company requests that these papers be handled in a manner consistent with this designation.
