AMENDED APPLICATION TO INTERVENE

On July 3, 2006, The Empire District Electric Company (Empire) filed its Application to Intervene in the above-entitled matter pursuant to Missouri Public Service Commission (Commission) Rule 4 CSR 240-2.075 and the Commission's Order and Notice. In accordance with Commission Rule 4 CSR 240-2.080(20), Empire now seeks leave to amend that application for the sole purpose of changing the names of the individuals designated in paragraph 5 of the original application who are to receive pleadings, notices, orders, and other correspondence and communications concerning the application. The remainder of the application remains unchanged. Empire requests that it be allowed to intervene in the above-entitled matter and in support of its amended application states as follows:

1. Empire is a Kansas corporation with its principal office and place of business at 602 Joplin Street (P.O. Box 127), Joplin, Missouri 64801 (64802). Empire is engaged in the business of providing electric and water utility services to customers in its service areas in Missouri. Empire also holds a certificate of service authority to provide certain telecommunications services.

2. Empire is an "electrical corporation," a "water corporation," a "telecommunications company," and a "public utility" as those terms are defined in

Section 386.020 RSMo 2000, and is subject to the jurisdiction and supervision of the Commission, as provided by law.

3. Empire has no final, unsatisfied judgments or decisions against it from state or federal regulatory agencies or courts that involve customer service and that have occurred within the three (3) years immediately preceding the filing of this application, and has no overdue Commission annual reports or assessment fees. Empire has a general rate case pending before the Commission, Case No. ER-2006-0315.

4. Empire's documents of incorporation were filed with the Commission in Case No. EF-94-39 and said documents are incorporated herein by reference in accordance with 4 CSR 240-2.060(1)(G). A Certificate of Authority from the Missouri Secretary of State to the effect that Empire, a foreign corporation, is authorized to do business in the State of Missouri, was filed with the Commission in Case No. EM-2000-369 and is also incorporated by reference.

6. As an electric utility, Empire's interests differ from those of the general public. Although the company does not currently know what position it will take in this

case, Empire's interests will be directly affected and could be adversely affected by any changes to the PURPA Section 111(d)(15) Interconnection Standard that are ordered by the Commission. It is, therefore, important that Empire be allowed to fully participate in this case so that it can protect its own interests as well as those of its stakeholders. In addition, allowing Empire to participate as an intervenor would serve the public interest because it will afford the company an opportunity to provide useful and relevant information that may aid the Commission in its deliberations.

WHEREFORE, Empire prays that the Commission issue its order granting the company permission to intervene in the above-entitled matter.
