

ORDER REGARDING PROTECTIVE ORDER

On January 19, 2005, SBC Missouri filed a motion for protective order. That motion indicated that the parties to this case will need to review confidential information contained in SBC's revised cost studies. This case was opened to consider the United States District Court's remand of the Commission's decision in TO-2001-438. A protective order was issued in TO-2001-438 and SBC asks that the Commission enter an order confirming that the existing protective order from the original case, and the non-disclosure agreements executed by the parties in that case, also apply in the remand case. The motion represents that no party would object to such an order.

SBC's motion is well taken and will be granted.

1. That the protective order issued in TO-2001-438, and the non-disclosure agreements executed by the parties in that case, remain in effect for this case.
