### UNANIMOUS MOTION TO SUSPEND PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission (Staff) by and through one of its attorneys, and on behalf of the parties to this case, respectfully asks that the Missouri Public Service Commission (Commission) issue an Order Suspending the Procedural Schedule previously set in this matter. In support of this request, the Staff states the following:

- 1. On March 31<sup>st</sup>, 2000, the Commission entered an Order Adopting a Procedural Schedule in this case.
- 2. On August 28, 2000, a Pre-Hearing Conference in this matter began and possible avenues of settlement were pursued by the parties in attendance. The efforts to settle the case were successful, and an agreement, in principle, has been reached by the parties.
- 3. Additional time, however, is needed by the parties to reduce the details of this settlement into a written agreement that can be presented to the Commission for its review and approval.

4. Staff has consulted with the parties and believes that a written Stipulation and Agreement will be available for filing no later than September 22<sup>nd</sup>, 2000.

WHEREFORE, based upon the foregoing, the Staff respectfully asks that the Commission enter an Order Suspending the Procedural Schedule previously set in this case and allowing the parties until September 22, 2000, to file a Stipulation and Agreement for the Commission's review.
