**APPLICATION TO CANCEL
CERTIFICATE OF SERVICE AUTHORITY AND TARIFFS**

COMES NOW United States Advanced Network, Inc. ("USAN"), through its undersigned counsel, and pursuant to 4 CSR 240-2.060 and §392.410(5), RSMo 2000, respectfully requests the Missouri Public Service Commission ("Commission") to cancel its Certificate of Service Authority and Tariff. In support of its Application, states as follows:

1. USAN is a Georgia corporation with principal offices located at 3080 Northwoods Circle, Norcross, Georgia 30071. The Commission issued USAN a Certificate of Service Authority to provide intrastate interexchange telecommunications services within the state of Missouri in Case No. TA-99-414.

2. USAN' certificate of authority to do business from the Missouri secretary of state was provided in Case No. TA-99-414. Pursuant to 4 CSR 240-2.060(G), USAN requests that the certificate and registration be incorporated by reference herein.

3. USAN does not currently have any customers in the state of Missouri and, as its business plans have changed, USAN no longer intends to provide telecommunications service in Missouri. Accordingly, USAN customer notification is not necessary and there is no customer impact associated with approval of this petition.

4. USAN does not have any pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or

rates, which action, judgment or decision has occurred within three (3) years of the date of the application. USAN does not, to the best of its knowledge, have any overdue annual reports or assessment fees.



6. Cancellation of USAN' Certificate of Service Authority and tariffs is not detrimental to the public interest. The public will not be harmed by USAN' withdrawal because, as stated above, USAN does not provide any telecommunications services to customers in Missouri, and thus, no customers will be affected. Furthermore, there are many other alternative telecommunications providers from whom Missouri residents can purchase interexchange telecommunications services.





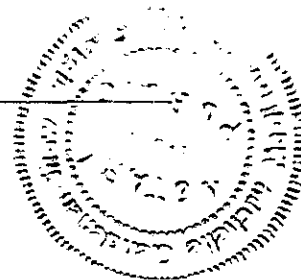
