On September 26, 2008, Trigen-Kansas City Energy Corporation ("Trigen") filed herein its compliance tariff sheets in compliance with the Commission's *Order Approving Unanimous Stipulation and Agreement and Authorizing Tariff Filing* issued in Case No. HR-2008-0300 on September 18, 2008. Pursuant to said Order, and the Unanimous Stipulation and Agreement in Case No. HR-2008-0300, the compliance tariff sheets filed by Trigen on September 26 reflected the specimen tariff sheets attached to the Stipulation, which were ultimately attached to the Order.


During its review of Trigen's compliance tariff filing, Staff discovered an inadvertent transposition error on one of the tariff sheets (\$10,995.54 should have been \$10,955.54) and requested Trigen file a substitute tariff sheet to correct this error. Therefore, at Staff's request, Trigen is filing the enclosed substitute tariff sheet to correct this error pursuant to Staff's instructions. The substitute tariff sheet being filed is as follows:

All of the other tariff sheets filed herein by Trigen on September 26, 2008, remain as filed on September 26, 2008. Trigen is still requesting an effective date of November 1, 2008, for **all** of the tariff sheets pursuant to the Unanimous Stipulation and Agreement.
