**MOTION TO CLASSIFY PREVIOUSLY FILED LETTER

Come Now TCG St. Louis and TCG Kansas City (hereinafter "TCG") and for their Motion to Classify Previously Filed Letter as Highly Confidential, state:

1. On June 17, 2002, TCG and NuVox Communications of Missouri, Inc. jointly filed a pleading entitled "Motion to Strike Portions of SWBT's Reply Brief."

2. Attached to that Motion to Strike were a series of letters between Carl Lumley, attorney for TCG, and Ms. Mimi MacDonald attorney for Southwestern Bell Telephone Company ("SWBT"). The letter dated May 1, 2002 from Ms. MacDonald to Mr. Lumley contains highly confidential information regarding the number of TCG's business lines and should be classified as highly confidential (HC) under the Protective Order established for this case.

Wherefore, TCG respectfully requests the Commission grant its Motion to Classify and order the parties to destroy the unclassified copy of the May 1, 2002 letter.
