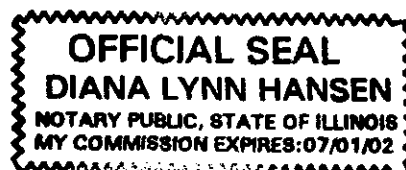

3 **Direct Testimony of Barbara Jablonski**

4 **INTRODUCTION**

5 **Q. What is your name and business address?**

6 A. My name is Barbara Jablonski and my address is 2000 West Ameritech
7 Center Drive, Room 3E27F, Hoffman Estates, Illinois, 60196.

8 **Q. By whom are you employed and what is your title?**

9 A. I am employed by SBC Operations, Inc., as Associate Director – Business
10 Usage and I am responsible for life cycle management of Southwestern
11 Bell Telephone Company's (SWBT's), Ameritech's, Pacific Bell's, and
12 Nevada Bell's intraLATA toll service, and SWBT's Local Plus® service and
13 Optional Metropolitan Calling Area (MCA) service.

14 **Q. Please describe your work history.**

15 A. I have worked for SBC affiliated companies since 1987 in various
16 positions including Legal (administration), Regulatory (tariff administration,
17 rate manager for usage), and Product Management for usage and toll.
18 Prior to this time, I worked for Teletype, a subsidiary of Western
19 Electric/AT&T, performing administrative functions.

20 **Q. Have you previously testified before the Missouri Public Service
21 Commission (Commission)?**

22 A. No.

23 **Q. What will you be discussing in your testimony?**

1 A. I will discuss the following group of services for business and residential
2 customers:

- 3 • IntraLATA toll,
- 4 • Local Plus®,
- 5 • Optional Metropolitan Calling Area (MCA) Service, and
- 6 • Wide Area Telecommunications Service (WATS) and 800 services.

7 While Local Plus is considered a hybrid of local and toll, and MCA service
8 is considered local service for ease of reference, I will refer to these
9 services and the toll services I discuss collectively as "interexchange
10 services".

11 **Q. Have you provided a description of the products you will discuss in**
12 **your testimony?**

13 A. Yes, please see Schedule 1.

14 **Q. What is the purpose of your testimony?**

15 A. The purpose of my testimony is to address the competitive retail market
16 across the state of Missouri for SWBT's interexchange services. My
17 testimony is applicable to both residential and business customers. I will
18 demonstrate that effective competition exists for SWBT's interexchange
19 services, and therefore the Commission should confirm that a competitive
20 classification for SWBT's interexchange services is appropriate.

21 **Q. Can you summarize the main points of your testimony for the**
22 **Commission?**

1 A. The Commission should understand the following points about my
2 testimony:

- 3 • On January 10, 1999, SWBT's intraLATA toll and 800 WATS became
4 classified as competitive.
- 5 • There are many providers offering interexchange services that are
6 functionally equivalent to and/or substitutable for SWBT's interexchange
7 services.
- 8 • Consumers have many choices, including many unregulated/non-
9 traditional providers that offer similar services that are functionally
10 equivalent to and/or substitutable for interexchange services offered by
11 SWBT.
- 12 • Competitive local exchange carriers (CLECs) offer functionally equivalent
13 and substitutable services to the interexchange services offered by SWBT.
14 In addition, SWBT's interexchange services faced competition from
15 interexchange carriers (IXCs) long before the passage of the
16 Telecommunications Act of 1996 (the Act) which facilitated CLEC entry.
- 17 • Customers will benefit from a competitive classification for SWBT's
18 intraLATA toll, Optional MCA, Local Plus, WATS and 800 services
19 because SWBT will be more fully able to compete in the changing
20 marketplace and better able to respond to changing customer demands.

21 **Q. Please describe the outline of your testimony.**

22 A. The outline of my testimony is as follows:

- 1 • First, I will describe the competitive nature of the intraLATA toll market in
2 Missouri and explain why the Commission should acknowledge the
3 competitive classification for intraLATA toll services and confirm that price
4 cap pricing constraints do not apply.
- 5 • Second, I will describe the competitive environment for SWBT's Optional
6 MCA service and explain why the Commission should find that Optional
7 MCA service faces effective competition.
- 8 • Third, I will describe the competitive nature of the Local Plus market and
9 explain why the Commission should find that SWBT's Local Plus service
10 faces effective competition.
- 11 • Finally, I will describe the competitive nature of the WATS and 800
12 services market and explain why the Commission should find these SWBT
13 services face effective competition.
- 14 • In each section, I will provide a brief history of the regulatory environment
15 for the product, describe what traditional forms of competition SWBT's
16 services face, describe what non-traditional forms of competition SWBT
17 faces and discuss the functionally equivalent status and substitutability of
18 available alternatives.
- 19 • At the end of my testimony, I will provide concluding comments
20 summarizing why the Commission should to confirm that SWBT's
21 intraLATA toll, WATS, 800, Optional MCA and Local Plus services face
22 effective competition and should be classified as competitive.

IntraLATA Toll Service

Q. Would you please briefly describe the intraLATA toll service?

A. IntraLATA toll furnishes telecommunications between service points in different local service areas within the same LATA. In other words, it is the ability to make a telephone call to someone outside your local calling scope but within the LATA.

Q. Would you please generally describe the regulatory history of intraLATA toll?

A. In the Commission's July 24, 1986 Report and Order, in Case No. TO-84-222, et. al., the Commission authorized intraLATA toll competition in Missouri. The Commission found that intraLATA toll competition was in the public interest and would result in new and improved services, lower prices and faster responses to customers' needs. SWBT's intraLATA toll, along with Operator Service charges associated with Station-to-Station, Calling Card and Person-to-Person services were classified as transitionally competitive on January 10, 1993, in Case No. TO-93-116. In its December 21, 1992 Order in Case No. TO-93-116, the Commission found that SWBT's Message Telecommunications Service (MTS) service was substitutable for interexchange carrier IXC MTS; that SWBT's 800 and Maximizer® 800 service was substitutable for the IXCs 800 service, and that SWBT's WATS was substitutable for IXC WATS. At the end of a three-year period on January 10, 1996, SWBT agreed and the Commission ordered the transitionally competitive designation to be

1 extended for an additional three years. At the expiration of a three-year
2 extension, on January 10, 1999, SWBT's transitionally competitive
3 services automatically became classified as competitive. This
4 classification is discussed in detail in Thomas Hughes' Direct Testimony.

5 **Q. Please briefly describe the regulatory history of IXCs.**

6 A. As discussed further in Thomas Hughes' Direct Testimony, on September
7 15, 1989, in Case No. TO-88-142, the Commission found all services of
8 IXCs, other than AT&T, to be competitive and declared them to be
9 competitive carriers. The Commission found AT&T's WATS and other
10 services to be competitive. Further the Commission found AT&T's MTS
11 and ancillary/complementary services to be transitionally competitive.

12 **Q. What types of traditional competition do SWBT's intraLATA toll**
13 **services face?**

14 A. Currently there are over 600 interexchange carriers certified to provide
15 intrastate interexchange service in Missouri. A list of IXCs certified in
16 Missouri is attached to my testimony in Schedule 2. The market for
17 intraLATA toll includes IXCs that offer both intraLATA and interLATA toll
18 service that enable the IXCs to offer one-stop shopping.

19 **Q. Who are the traditional competitors for intraLATA toll?**

20 A. AT&T, Sprint and MCI are the three largest intraLATA toll service
21 competitors, and are among the more than 600 certified IXCs authorized
22 to provide toll service in Missouri. The number of certified companies

1 indicates that customer choices are widely available and reflects the
2 relative ease of entry for firms wishing to enter the intraLATA toll market.

3 **Q. Can IXC provide intraLATA toll on a 1+ basis?**

4 A. Yes. With the implementation of intraLATA presubscription in July 1999,
5 IXC now offer their customers the ability to make intraLATA toll calls
6 without dialing extra digits. Even prior to presubscription, customers had
7 the ability to program their PBXs and key systems to automatically route
8 intraLATA calls to the IXC of their choice. In addition, customers had the
9 option of dialing 10XXX to utilize the IXC of their choice. For nearly two
10 years, however, customers have the ability to select among a significant
11 number of IXCs to be their 1+ provider of intraLATA toll service. That is,
12 when the customer dials 1 before dialing the area code and telephone
13 number of the customer they are wanting to call, the call is automatically
14 routed to the carrier that the customer has selected to provide their
15 intraLATA toll service. Furthermore, while 1+ intraLATA presubscription
16 has been in place in for almost two years, customers can still select the
17 IXC of their choice by dialing 101-xxxx (e.g. 10-10-ATT) before the
18 telephone number of the person they are wanting to call. This "dial-
19 around" capability permits customers to use the IXC of their choice even if
20 they retain SWBT as their 1+ intraLATA toll provider.

21 **Q. In addition to the numerous IXCs that provide intraLATA toll service,**
22 **do CLECs also provide intraLATA toll service?**

1 A. Yes. CLECs also provide intraLATA toll service. When SWBT loses a
2 customer to a CLEC, SWBT may also lose the intraLATA toll that the
3 customer previously purchased.

4 **Q. What types of non-traditional alternatives exist that are functionally**
5 **equivalent to or substitutable for SWBT's intraLATA toll service?**

6 A. In addition to the traditional forms of competition from IXC's and CLEC's,
7 SWBT customers have several non-traditional choices for intraLATA toll.
8 These choices include wireless service, which generally provides larger
9 local calling scopes; prepaid phone cards; and the Internet. Many
10 wireless providers offer free long distance packages, or unlimited long
11 distance for a flat-rate monthly fee. For example, Sprint PCS has wireless
12 packages that have nationwide local calling. If a PCS customer calls next
13 door or if the customer calls across the LATA, or across the nation, the
14 call costs the same to the customer. Sprint's package simply treats each
15 call as a minute used on the customer plan. So a customer with a large
16 block of minutes included as part of their basic wireless service, can make
17 "intraLATA toll" calls for "free" – that is at no additional cost beyond the
18 cost of the packaged minutes.

19 Other forms of non-traditional alternatives include Internet-enabled
20 capabilities including Internet-telephony, email, and instant messaging.
21 The use of Internet-telephony is growing. The ability to make free, or at
22 least very inexpensive, calls to other people outside your local calling
23 scope, but within the LATA, makes Internet-telephony an attractive

1 substitute for SWBT's intraLATA toll service. Moreover, the rapidly
2 expanding use of email and instant messaging also provide the means for
3 communicating with other people without having to pay for an intraLATA
4 toll call provided by SWBT.

5 **Q. In each exchange in Missouri, how many IXC's are available to be**
6 **selected as a 1+ provider?**

7 A. In my Schedule 3, I have provided the number of IXC's that are available
8 to be selected as a 1+ intraLATA toll service provider in each SWBT
9 exchange. As evidenced by the information contained in Schedule 3, in
10 every SWBT exchange there are a minimum of 73 IXC's available to be
11 selected by the customer to be their 1+ intraLATA toll provider. Some
12 exchanges have up to 140 IXC's. Based on the number of available IXC's
13 in each SWBT exchange, it is very apparent that robust competition
14 exists for SWBT's intraLATA toll services.

15 **Q. Are these services provided by IXC's functionally equivalent to or**
16 **substitutable for SWBT's services?**

17 A. Yes, the intraLATA toll services provided by AT&T, Sprint, MCI
18 WorldCom, and other IXC's are equivalent to or substitutable for SWBT's
19 intraLATA toll service in that all these services provide customers with the
20 ability to place intraLATA toll calls.

1 **Q. Are these alternatives available in all of SWBT's exchanges in**
2 **Missouri?**

3 A. Yes. At a minimum, I have demonstrated that there are at least 74 IXCs
4 available in every exchange, in addition to CLECs and non-traditional
5 alternatives that are available in all SWBT exchanges.

6 **Q. Does SWBT face effective competition for intraLATA toll services in**
7 **all its exchanges?**

8 A. Yes. SWBT's intraLATA toll service faces effective competition in all its
9 exchanges as demonstrated in my testimony. Moreover, the Commission
10 should acknowledge that SWBT's intraLATA toll services already have a
11 competitive classification, and confirm that the price cap rules do not apply
12 to these services.

13 **Optional Metropolitan Calling Area (MCA)**

14 **Q. Would you please describe Optional MCA service?**

15 A. Optional Metropolitan Calling Area is an optional interexchange plan
16 available in three distinct areas in Missouri: the St. Louis MCA, the Kansas
17 City MCA and the Springfield MCA. This optional plan provides
18 subscribers with a calling area which includes the respective Metropolitan
19 Exchange and certain customers in other exchanges where MCA service
20 is also available. Please see Schedules 4, 5, and 6, which show the
21 exchanges included in the optional MCA service, the rates charged for the
22 service, and the calling scopes.

23 **Q. Generally describe the regulatory history of the MCA service.**

1 The MCA service was created by the Commission in Case No. TO-92-
2 306. The service was created to address customer requests for expanded
3 calling scopes in the areas surrounding the three major metropolitan areas
4 of St. Louis, Kansas City and Springfield. The existing calling scopes
5 were modified to address the changing demographics of the metropolitan
6 areas by creating an optional service that expands the local calling scopes
7 for a flat rate monthly charge.

8 **Q. What types of competition does Optional MCA face?**

9 A. CLECs, both facilities based and resale, provide Optional MCA service to
10 customers. For instance, see Allegiance Telecom of Missouri, Inc.'s tariff,
11 Section 3.1 for details on its Optional MCA service and rates. Allegiance
12 charges a rate of \$24.80, regardless of the MCA tier in which the customer
13 resides, and has complete pricing flexibility for this service. In addition to
14 facilities based and resale competition from CLECs, Optional MCA service
15 faces competition from IXCs as described in the intraLATA toll section of
16 my testimony.

17 **Q. What types of non-traditional competition does your MCA service**
18 **face?**

19 A. In addition to the numerous CLEC and IXC competitors, Optional MCA
20 service faces competition from non-traditional competitors such as
21 wireless providers and Internet based communications. Wireless
22 providers often provide local calling scopes that are much larger than
23 SWBT's basic local calling scopes (e.g. the entire major trading area,

1 which extends well beyond the MCA boundaries). Many wireless
2 packages also include free long distance and unlimited calling during off-
3 peak times. Additionally, as I explained above for intraLATA toll service,
4 Internet enabled communications, such as e-mail, instant messaging, and
5 voice-over-IP, also compete with the Optional MCA service.

6 **Q. Who are the non-traditional competitors for MCA service?**

7 A. Non-traditional providers include wireless providers such as AT&T
8 Wireless, Verizon Wireless, Sprint PCS, and internet service providers.

9 **Q. How are the services of SWBT competitors functionally equivalent or**
10 **substitutable at comparable rates, terms and conditions?**

11 A. CLECs are offering customers local calling plans that allow their
12 subscribers to complete calls to other end users who were previously
13 outside the subscribers local calling scope. For example, CLECs are
14 offering customers local calling throughout the geography of the MCA
15 whether or not the called party is an MCA subscriber. These plans may
16 vary slightly in their pricing and calling scopes, however they offer the
17 same basic service or function to the customer – expanded local calling.

18 **Local Plus**

19 **Q. Please describe the Local Plus service.**

20 A. Local Plus is an optional 1-way outbound expanded calling plan that
21 provides subscribers flat rate unlimited calling to all customers within the
22 LATA. Local Plus is available to both business and residence customers.

1 **Q. Generally describe the regulatory history and competitive**
2 **environment for Local Plus.**

3 A. The Commission approved SWBT's Local Plus Service in November of
4 1998. Southwestern Bell implemented Local Plus in a limited number of
5 exchanges in December of 1998 and in the rest of the state in June of
6 1999.

7 Local Plus is available for resale by both CLECs and IXC. Several
8 CLECs are reselling Local Plus today. CLECs can also provide the
9 service via their own switch or unbundled network elements (UNEs).

10 **Q. What types of competition does Local Plus face?**

11 A. In addition to resale from CLECs and IXCs as described above, Local Plus
12 also faces competition from IXCs as described in the intraLATA toll
13 section of my testimony. IntraLATA toll calling plans offered by IXCs are
14 substitutable services for Local Plus. Both Local Plus and IXC calling
15 plans offer customers the ability to call outside their local calling scope,
16 but within the LATA. IXCs have many different toll calling plans, including
17 large block of time plans, that customers purchase instead of Local Plus.
18 Additionally, CLECs, have the option of reselling Local Plus as described
19 above. Facilities-based CLECs also have the option of creating their own
20 expanded local calling plans—equal to or even larger than the Local Plus
21 calling scopes.

22 **Q. Who are the competitors for Local Plus?**

1 A. Competitors for Local Plus include the numerous CLECs and IXC's
2 currently offering interexchange service in Missouri. CLECs that provide
3 local service to customers via their own switch may provide a calling
4 scope that is as large as they choose. A list of CLECs certified to provide
5 basic local exchange service in Missouri is included as Schedule 7.

6 **Q. What other types of competition does Local Plus face?**

7 A. In addition to the numerous CLECs and IXC's, Local Plus faces
8 competition from other competitors such as wireless providers and
9 Internet service providers. As I discussed above, wireless plans now
10 provide a very effective alternative to SWBT's services like Local Plus.
11 Customers who would normally place an intraLATA toll call using SWBT's
12 services would bypass SWBT's intraLATA toll service by using their
13 wireless. Furthermore, the Internet-enabled communications that I
14 described above (e.g., Internet-telephony, email, instant messaging)
15 provide additional alternatives to substitute for SWBT's Local Plus service.

16 **Q. Who are the other competitors for Local Plus?**

17 A. These providers include wireless providers such as AT&T Wireless,
18 Verizon Wireless, and Sprint PCS. Additionally, Internet enabled
19 communications, such as e-mail, instant messaging, and voice-over-IP,
20 compete with the Local Plus service. How wireless and Internet
21 communications compete with SWBT's interexchange service is
22 discussed more thoroughly in the intraLATA toll and Optional MCA service
23 sections of my testimony.

1 **Q. Are these services functionally equivalent to or substitutable for**
2 **SWBT's services?**

3 **A. Yes.**

4 **Q. How are they functionally equivalent or substitutable at comparable**
5 **rates, terms and conditions?**

6 **A. All of the calling plans offered by these various providers allow a**
7 **subscriber to complete a call to other customers located outside the**
8 **subscriber's traditional basic local calling scopes. Although the plans may**
9 **vary in their structures (e.g. flat rate, block of time, etc.), they all offer the**
10 **same basic service and function to the customer. All of these plans allow**
11 **for calling within the customers LATA.**

12 **WATS and 800 WATS type services**

13 **Q. Would you please describe WATS and 800 WATS type services?**

14 **A. The acronym WATS includes both 800 Service and Outward WATS,**
15 **which is abbreviated to OUTWATS. The 800 Service provides for**
16 **incoming calls that are toll-free to the calling party; OUTWATS Service**
17 **provides for outgoing calls that are billed on a usage sensitive basis.**

18 **Q. Generally describe the regulatory history and the competitive**
19 **environment for 800 WATS.**

20 **A. SWBT's WATS (800 and OUTWATS) was determined to be transitionally**
21 **competitive by the Commission as of January 10, 1993, in Case No. TO-**
22 **93-116. In its December 21, 1992 Order, the Commission found that**
23 **SWBT's 800 and Maximizer® 800 service was substitutable for the IXC's**

1 800 service, and that SWBT's WATS was substitutable for IXC WATS. At
2 the expiration of a three-year extension, on January 10, 1999, SWBT's
3 transitionally competitive services automatically became classified as
4 competitive. This classification is discussed in detail in Thomas Hughes'
5 Direct Testimony.

6 **Q. What types of traditional competition do WATS and 800 services**
7 **face?**

8 A. IXCs are the major WATS and 800 service competitors. There are over
9 600 certified IXCs authorized to provide interexchange services in
10 Missouri. As part of their interexchange services, IXCs typically provide
11 800 services to customers. IXCs have the advantage of offering 800
12 service that permits both intraLATA and interLATA calling into the 800
13 number which provides a significant advantage over SWBT's services.
14 The number of certified companies indicates that customer choices are
15 available and reflects the relative ease of entry for firms wishing to enter
16 the WATS market.

17 **Q. What types of non-traditional competition does WATS and 800**
18 **services face?**

19 A. In addition to IXCs and CLECs, WATS service faces competition from
20 non-traditional competitors. Many companies are utilizing various e-
21 commerce methods to communicate with their customers. For instance,
22 consumers can purchase airplane tickets, rent cars, or check the balance
23 on their credit card via the Internet; therefore, placing a call to a

1 company's 800 number is unnecessary. In addition to the IXCs, since the
2 passage of the Act, CLECs have been providing these services. As an
3 example, Excel Telecommunications, Inc. offers 800 services. For terms
4 and conditions and rates, see Section 4.7 of *Missouri PS.C. Tariff No. 2*.

5 **Q. Are these services functionally equivalent to or substitutable for**
6 **SWBT's WATS and 800 services?**

7 **A. Yes.**

8 **General Information on SWBT's Interexchange Services**

9 **Q. How will customers benefit from SWBT having equal regulatory**
10 **treatment with respect to the classification of its services?**

11 **A. Acknowledging that SWBT's intraLATA toll and WATS services are**
12 **competitive and declaring SWBT's Optional MCA and Local Plus services**
13 **to be competitive will lead to a more robustly competitive market and will**
14 **provide consumers greater choices in the market. Confirming that**
15 **SWBT's interexchange services face effective competition would allow**
16 **SWBT to more easily enhance its service offerings and respond to**
17 **customers' changing needs.**

18 **Q. Why should this Commission declare these interexchange services**
19 **to be competitive?**

20 **A. The Commission should declare SWBT's interexchange services as**
21 **competitive because they face effective competition from other**
22 **telecommunications providers as demonstrated in my testimony.**

1 Classifying interexchange services as competitive will provide SWBT the
2 flexibility to respond to changing customers' needs in interexchange
3 market. A market driven environment, not regulation, will drive
4 competitors to innovate through new product development, packaging and
5 bundling of products, which will lead to increased pricing options, more
6 promotions, and improved customer service. The inability to quickly adapt
7 in a dynamic market places SWBT at a decided disadvantage because it
8 renders SWBT's services more rigid and less attractive to customers
9 changing needs. Competitively classified and non regulated competitors
10 are better able to respond to consumers changing needs for
11 interexchange services. Classification of SWBT's interexchange services
12 as competitive will benefit consumers by allowing all competitors to
13 compete on an even footing and thereby increase choices available to
14 consumers.

15 **Q. How do the current pricing constraints impact SWBT's ability to**
16 **market your interexchange services?**

17 **A.** There are instances where SWBT would consider restructuring its prices
18 to meet current market conditions. For example, many IXC's have
19 postalized rates for their intraLATA toll services. They offer flat rate, per
20 minute-of-use charges based on the time of day and day of the week in
21 which the call is placed. Their rates are not distance sensitive as are
22 SWBT's. Under the current price cap regulations, SWBT may be limited in

1 its ability to restructure its distance sensitive rates to meet consumer
2 desires.

3 Another example involves a service NuVox Communications (formerly
4 Gabriel) is offering. NuVox essentially offers a one-way MCA plan that
5 allows local calling within all the MCA tiers on a flat-rate basis. It does not
6 limit local calling in the optional tiers to only those customers that
7 subscribe to optional MCA and it does not have an additional rate for the
8 service. The MCA wide calling scope is included with the access line.

9 Under the current pricing restrictions, SWBT may be limited in its ability to
10 restructure its MCA service, and thus, consumers have fewer choices.

11 **Q. Please summarize your testimony.**

12 **A.** My testimony has shown that SWBT's interexchange services have
13 faced, and continue to face, effective competition. Consumers in Missouri
14 have various competitive options for their interexchange needs. SWBT
15 faces many traditional and non-traditional forms of competition.
16 Customers can use IXCs, CLECs, wireless service, Internet based
17 communications, etc. to meet their interexchange communications needs.
18 The services of these providers are functionally equivalent to or
19 substitutable for SWBT's interexchange services. Moreover, most of
20 SWBT's competitors are subject to much less regulatory scrutiny, which
21 places SWBT at a competitive disadvantage. SWBT needs to be
22 regulated like its IXC and CLEC competitors in order to remain competitive
23 in the interexchange market. Based on the interexchange service options

1 available to all customers in Missouri, the Commission should declare
2 SWBT's interexchange services to be competitive.

3 **Q. Does this conclude your testimony?**

4 **A.** Yes, it does.

Interexchange Services Descriptions:

Long Distance Message Telecommunications Service (LDMTS) is a service that provides telecommunications between service points in different local service areas within the same LATA. Calls are rated based on a mileage band table and on an originated and additional minute of use. Calls are generally completed without the assistance of an operator.

Optional Metropolitan Calling Area

Optional Metropolitan Calling Area is an optional interexchange plan available in three distinct areas in Missouri: the St. Louis MCA, the Kansas City MCA and the Springfield MCA. This optional plan provides subscribers with an optional calling area which includes the respective Metropolitan Exchange and certain customers in other exchanges where MCA service is also available. For subscribing customers in MCA 2 the calling scope includes all customers in the Springfield Metropolitan Exchange and MCA subscribers in MCA 2; For subscribing customers in MCA 3 the calling scope includes all customers in the Metropolitan Exchange, all customers in MCA 3 exchanges and MCA subscribers in MCA 4 and 5. For subscribing customers in MCA 4 the calling scope is all customers in the Metropolitan Exchange, all customers in MCA 3 and 4 and MCA subscribers in MCA 5. For subscribing customers in MCA 5 the calling scope is all customers in the Metropolitan Exchange, all customers in MCA 3 and 4 and MCA subscribers in MCA 5.

Local Plus

Local Plus is an optional 1-way outbound expanded calling plan that provides subscribers flat rate unlimited calling to all customers within the LATA. Qualified usage includes intraLATA customer dialed, sent-paid, non-coin calls originating at a subscriber's access line and terminating at an access line in an exchange within the Local Plus calling scope.

Wide Area Telecommunications Service

WATS is a service for dial type telephone communications between a WATS access line and intraLATA service points within MO. WATS Access Line is a line provided for purpose of completing WATS calls and is arranged for either Outward WATS or 800 Service.

Outward WATS – provides for dial type communications on an Outward WATS access line to intraLATA local and toll service points within Missouri.

800 Service – provides for dial type communications on an 800 Service WATS access line from intraLATA service points within Missouri.

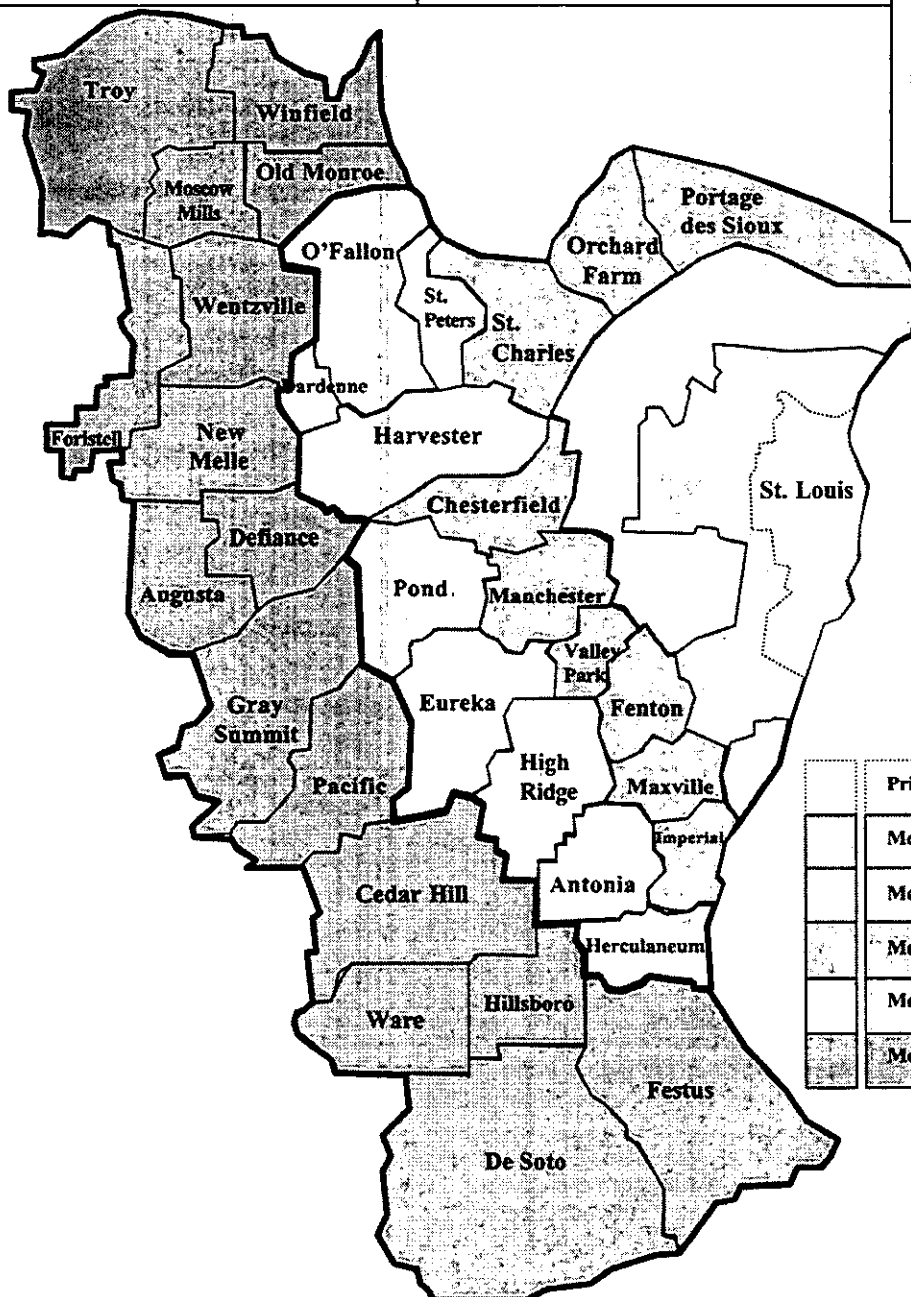

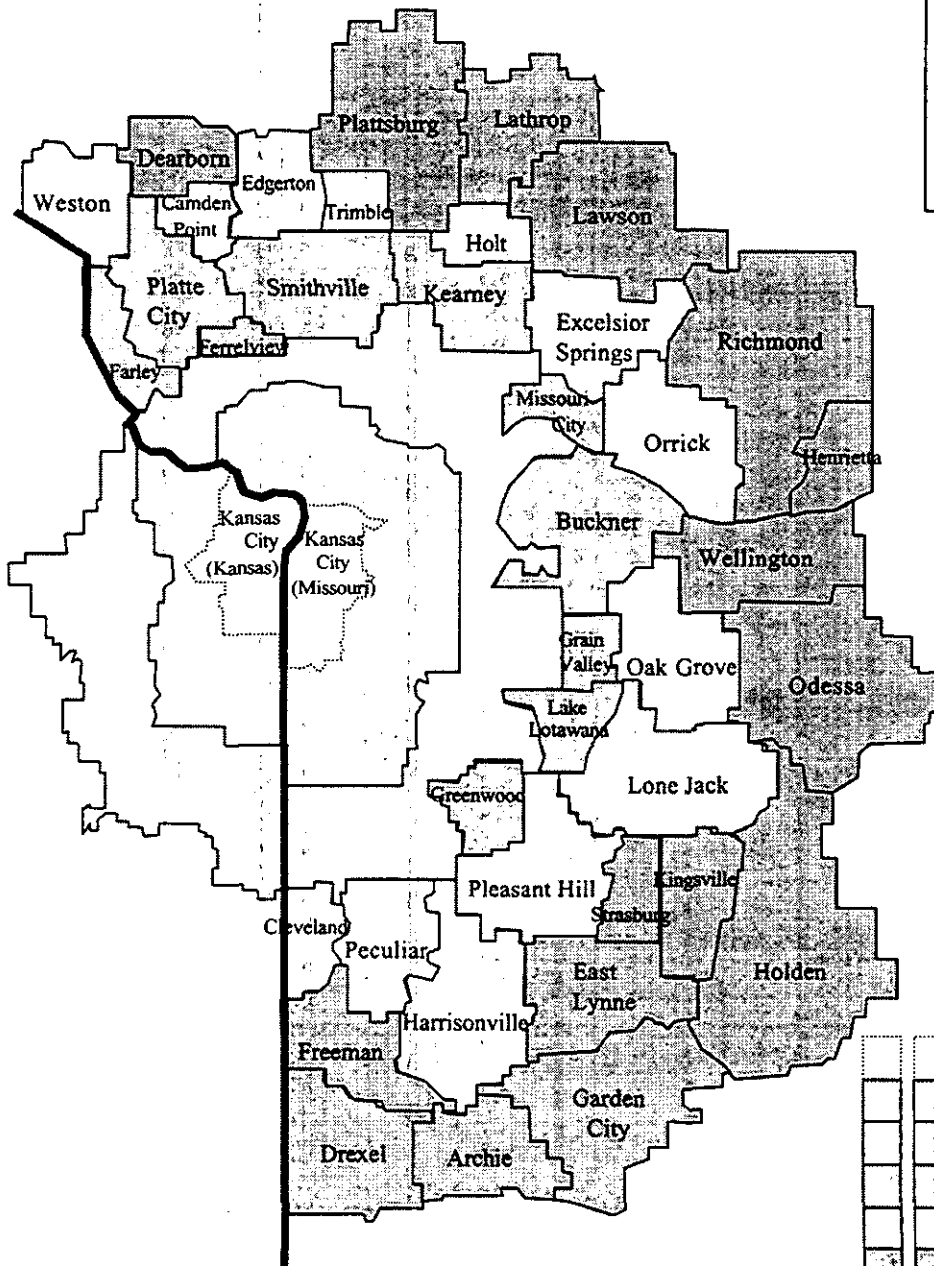
