STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On February 4, 2008, Syniverse Networks, Inc. (Syniverse) filed a request to cancel its Certificate of Service Authority issued in Case No. XA-2004-0187.

2. Because Syniverse has requested cancellation of its certificate and it is not providing telecommunications service in Missouri, the Staff recommends that the Commission issue an order canceling the company's certificate of service authority. See Appendix A.

3. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo, which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

4. The Commission need not hold a hearing in the present matter, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, the Staff recommends that the Commission cancel the Certificate of Service Authority it has granted to Syniverse Networks, Inc.

On February 04, 2008, Syniverse Networks, Inc. f/k/a TSI Telecommunications Network Services, Inc. (Syniverse), a competitive telecommunications company, filed its Application for the Cancellation of Certificates of Service Authority. Syniverse was granted a certificate of service authority to provide interexchange and non-switched local exchange telecommunications service as TSI Telecommunications Network Services, Inc., on November 13, 2003 in Case No. XA-2004-0187.

According to Syniverse's application, the company has no customers in Missouri; therefore, the cancellation of its certificate is not detrimental to the public interest. The Staff has no objections to the request for cancellation and recommends that the Commission issue an order to cancel Syniverse's certificate of service authority to provide non-switched local and interexchange telecommunications service and the accompanying tariff, P.S.C. Mo. No. 1, effective as of June 28, 2004. According to its tariff, Syniverse offered only resold private line transport services to business customers. The Staff is unaware of any other filing which affects or which would be affected by this proposal.




