ORDER ESTABLISHING CASE

The Missouri Public Service Commission ordered the implementation of the Relay Missouri Program in Case No. TO-90-174. The Relay Missouri Program is a statewide dual-party telephone relay service for the deaf, hearing-impaired and speech-impaired, which was created by Section 209.253, RSMo 1994. By Commission order dated February 19, 1991, the initial surcharge was set at six cents (\$.06) per month per access line. Since that time, the surcharge has fluctuated, but since June 28, 2005, the surcharge has been set at 13 cents (\$.13) per month per access line.

Under Section 209.259, RSMo 2000, the Commission is required to review the surcharge periodically in order to ascertain that necessary funds are available for the provision of the program. The Commission last reviewed the surcharge in Case No. TO-2005-0308.

On February 13, 2007, the Staff of the Commission filed a motion requesting that the Commission open a case to review the surcharge that funds the Relay Missouri Program. The Commission will open the case and review the surcharge. The Commission

will also give interested parties an opportunity to intervene and to respond to Staff's recommendation. Accordingly, a copy of this order will be sent to all competitive local exchange carriers and incumbent local exchange carriers in Missouri. In addition, the Data Center shall send a copy of this order to all parties on the service list in Case No. TO-2005-0308 and the following:

Furthermore, the Commission will direct the Information Office to send a copy of this order to all members of the General Assembly and to all newspapers in the state of Missouri as listed in the Newspaper Directory of the current Official Manual of the State of Missouri.

IT IS ORDERED THAT:

1. Case No. TO-2007-0306 is established in order to review the current surcharge for the Relay Missouri Fund.
2. The Data Center of the Commission shall serve a copy of this order as described above.
3. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly and all newspapers in the state of Missouri as directed above.
