**ORDER APPROVING TARIFF FILING IN COMPLIANCE WITH**  
**COMMISSION ORDER**

On November 1, 2007,<sup>1</sup> Missouri American Water Company ("MAWC") filed a revised tariff sheet to be in compliance with the Commission's September 20 Order Approving Non-Unanimous Stipulation and Agreement as to MSD Rate Design Between MAWC and MSD. The new tariff filing was assigned tracking number YW-2008-0285, and bears an effective date of December 1.

The Commission directed its Staff to review the tariff sheet and file a report and recommendation stating whether MAWC's current tariff filing is in compliance with the Commission's September 20 Order approving the non-unanimous stipulation and agreement. On November 9, the Staff filed its recommendation. Staff reviewed the tariff sheet and states that it is in compliance with the Commission's Order. No proper party filed an objection to MAWC's tariff or to Staff's recommendation within the timelines allowed pursuant to Commission Rule 4 CSR 240-2.080(15).

The Commission has reviewed the tariff filing and Staff's verified recommendation and memorandum, which is hereby admitted into evidence. After considering Staff's recommendation, the Commission concludes that the proposed tariff sheet is consistent with the Commission's September 20 Order approving the non-unanimous stipulation and agreement and should be approved to become effective on and after December 1.

**IT IS ORDERED THAT:**

1. The tariff sheet filed by Missouri American Water Company on November 1, 2007, pursuant to the Commission's September 20 Order Approving Non-Unanimous Stipulation and Agreement as to MSD Rate Design Between MAWC and MSD, assigned Tariff Tracking Number YW-2008-0285, bearing an effective date of December 1, 2007, is approved to become effective on December 1, 2007. The tariff sheet approved is:
