# ORDER APPROVING UNANIMOUS DISPOSITION AGREEMENTS AND AUTHORIZING TARIFF FILINGS

Issue Date: August 12, 2009 Effective Date: August 22, 2009

On October 23, 2008, Osage Water Company, Inc. initiated small company revenue increase requests for both water and sewer service, pursuant to Commission Rule 4 CSR 240-3.050. The Commission assigned the water rate increase request file number WR-2009-0149, and assigned the sewer rate increase request file number SR-2009-0152. The Commission consolidated the two cases into file number WR-2009-0149 on July 14, 2009.

On May 21, the Commission's Staff filed disposition agreements executed by it and Osage Water in both the water and sewer cases. The Office of the Public Counsel did not sign either disposition agreement and initially opposed those agreements. Because of Public Counsel's opposition, the Commission suspended the tariffs filed by Osage Water to implement the disposition agreements until September 23.

On August 3, Staff filed unanimous disposition agreements, signed by Public Counsel as well as by Osage Water and Staff, regarding both the water and the sewer rate increase requests. The agreements would allow Osage Water to increase its rates to generate additional annual water revenue of \$48,500, and additional annual sewer revenue

of \$13,500. Both agreements require Osage Water to file revised tariffs to implement the agreed upon rate increases. In addition, both agreements require Osage Water to take specified actions to improve the service it offers to its customers.

The Commission has reviewed the unanimous disposition agreement and concludes that they will result in water and sewer rates that are just and reasonable. The Commission will approve the agreements.

#### THE COMMISSION ORDERS THAT:

- 1. The Unanimous Disposition Agreement regarding Osage Water Company, Inc.'s request for an increase in water revenue, filed on August 3, 2009, is approved.
- 2. The signatories shall comply with the terms of the Unanimous Disposition Agreement regarding Osage Water Company's request for an increase in water revenue. A copy of that agreement is attached to this order as Appendix A.
- 3. The following tariff sheets issued by Osage Water Company, Inc. on May 26, 2009, and assigned Tariff File No. YW-2009-0830, are rejected. The tariff sheets rejected are:
