The Commission previously directed the filing of post-hearing briefs and proposed findings of fact and conclusions of law to be due on April 13, 2007. Because the official transcripts to the primary evidentiary hearing were filed later than anticipated, and because

the Commission held an ancillary evidentiary hearing in these matters on March 30, 2007, the Commission will reset the due date for these filings.

IT IS ORDERED THAT:

1. All post-hearing briefs shall be filed with the Commission no later than April 20, 2007.

2. All briefs and amendments shall be filed in accordance with Commission Rule 4 CSR 240-2.080, and as directed in the Commission's March 5, 2007 order setting the original briefing schedule. Briefs shall follow the same list of issues as filed in the case and must set forth and cite the proper portions of the record concerning the remaining unresolved issues that are to be decided by the Commission.

3. No later than April 20, 2007, the parties shall prepare and file with the Commission proposed findings of fact and conclusions of law, including citations to testimony and other evidence as directed in the body of this order.

4. All parties shall provide an electronic copy of their briefs and proposed findings of fact and conclusions of law, in Microsoft Word format, to the regulatory law judge at harold.stearley@psc.mo.gov.

5. This order shall become effective on March 30, 2007.
