ORDER SETTING LOCAL PUBLIC HEARING

On May 5, 2005, Algonquin Water Resources of Missouri, LLC requested that the Commission approve its water and sewer tariffs that would implement general rate increases, Case Numbers WR-2006-0425 and SR-2006-0426. The two cases were consolidated on May 23, 2006, designating Case No. WR-2006-0425 as the lead case. In addition, the tariffs were suspended until April 2, 2007 to allow the Commission adequate time to study the effect of the proposed tariffs and to determine if they were just, reasonable, and in the public interest.

On June 26, 2006, the Parties jointly filed a proposed procedural schedule. The Commission had directed the Parties to include in that proposed schedule a recommendation for local public hearings to be held at a site near Algonquin's service territories. The Parties recommended one local public hearing to be held on a date prior to the time that the Staff and the Office of Public Counsel file their direct testimony on December 15, 2006.

The Commission will set a local public hearing in this case. The Staff of the Commission will hold an informal question-and-answer session beginning at 5:30 p.m. The hearing will begin at 6:00 p.m. and will conclude at 9:00 p.m., or when every person who

wishes to testify has done so, whichever is sooner. In addition, the Commission will direct the company to provide notice to its customers.

IT IS ORDERED THAT:

- 1. The Commission shall hold a local public hearing on December 6, 2006, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, at the ITV Room at Reeds Spring High School, 20277 State Hwy. 413 South, P.O. Box 718, Reeds Spring, Missouri 65737.
- 2. No later than November 20, 2006, Algonquin Water Resources of Missouri, LLC shall send an individual notice to each of its customers substantially as set out below.
