- 1. On September 28, 2006 (unless noted otherwise, all dates hereafter refer to the year 2006), the Commission issued an order approving a Unanimous Stipulation and Agreement (Agreement), which also was filed on September 28, in which it directed the Company to comply with the terms of the Agreement, ordered the Company to file a report no later than October 6 indicating what steps it has taken to review and remedy customer service complaints, and suspended the Company's pending revised tariff sheets related to this case until October 11.
- 2. On October 2 and October 3, Aqua RU, Inc. d/b/a Aqua Missouri Inc. ("Company") withdrew its pending revised tariff sheets originally filed for this case and submitted new revised tariff sheets intended to be in compliance with the Commission's September 28 order referenced in Paragraph 1 above.
- 3. The Staff has reviewed the new revised tariff sheets submitted by the Company on October 2 and October 3 and reports to the Commission that it believes those tariff sheets are in compliance with the Commission's September 28 order referenced in Paragraph 1 above.

WHEREFORE, the Staff respectfully recommends that the Commission issue an order approving the new revised tariff sheets that the Company submitted on October 2 and October 3, to be effective for service rendered on and after October 11, or sooner if possible.
