RE: Veolia Energy Kansas City, Inc. ("Veolia")

Dear Mr. Reed:

On behalf of Veolia, I am providing herewith to the Missouri Public Service Commission (the "Commission") for filing in electronic form certain tariff sheets consisting of revised steam rate schedules which are designed to increase Veolia's gross annual steam tariff revenues by approximately \$1,379,000, or 19%, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes. Also provided for filing in electronic form are certain tariff sheets consisting of revisions to Veolia's general rules and regulations. In addition, also included is the information required by 4 CSR 240-3.030(3)(B).

The proposed rate increase is driven by several factors. Veolia has not sought a rate increase since 2008 and none prior to that in its 21 year history. Despite increases in fuel, operating and maintenance costs over those years, Veolia has operated with a significant revenue deficiency over its history. This filing seeks to better align Veolia's costs and revenues. However, it should be noted that Veolia is only seeking an increase of approximately \$1,379,000, although this rate case filing would support an increase of about \$3,692,000. Other relatively small proposed changes are included in this filing.

Veolia is submitting a complete set of tariff sheets to reflect its recent name change. A list of those sheets is attached to this letter.

All of the listed schedules bear a date of issue of April 22, 2011, to be effective May 22, 2011.

Copies of this filing are being provided to the Commission's General counsel and Staff, and two sets of this filing are being furnished this date to the Office of the Public Counsel.
