ORDER OPENING A WORKING CASE TO CONSIDER AN AMENDMENT OF THE COMMISSION'S RULE ON ELECTRIC, GAS, AND WATER UTILITY STANDARDS OF QUALITY

The Staff of the Commission filed a motion on September 8, 2020, asking the Commission to open a working case to review and collect comments about a rule amendment it proposes that would modify the Commission's rule regarding electric, gas, and water utility standards of quality. Staff believes that an amendment to that rule is needed to address the growing biogas industry in Missouri.

Staff asks that stakeholders be invited to offer written comments regarding a draft rule amendment attached to Staff's motion. Staff also asks the Commission to provide notice of the establishment of this working case to the stakeholders identified by Staff. The Commission will establish this working case as requested by Staff.
