**ORDER APPROVING TARIFF IN COMPLIANCE**

Issue Date: July 5, 2007

Effective Date: July 15, 2007

On January 17, 2007,<sup>1</sup> Bilyeu Water Company, LLC (“Bilyeu”) filed an application with the Missouri Public Service Commission, pursuant to Section 393.170, RSMo 2000, requesting that the Commission grant it authority to construct, operate and maintain a water system as described in the caption of this order. On June 5, the Commission granted the certificate. In the Commission’s Order Granting Certificate of Public Convenience and Necessity (“Order”), the Commission directed Bilyeu to submit a complete tariff for its water service depicting its complete service area and customer rates.

On June 15, Bilyeu filed its tariff, bearing an effective date of July 15. In response, the Commission directed its Staff to review the tariff sheets and file a report and recommendation as to whether Bilyeu was in compliance with the Commission’s Order. On July 5, the Staff of the Missouri Public Service Commission filed its recommendation and

verified memorandum. Staff finds the tariff sheets to be in compliance with the Commission's Order and recommends that the Commission approve the submitted tariffs, or to allow them to go into effect by operation of law on their effective dates. The Commission has reviewed the tariff filings and Staff's verified recommendation and memorandum, which is hereby admitted into evidence, and finds that Bilyeu's tariffs should be approved.

**IT IS ORDERED THAT:**

1. The tariff sheets filed by Bilyeu Water Company, LLC on June 15, 2007, pursuant to the Commission's June 5, 2007, Order Granting Certificate of Public Convenience and Necessity, assigned Tariff No. YW-2007-0913, are approved to become effective on July 15, 2007. The tariff sheets approved are:
