Vodafone Global Enterprise Inc. ("VGEI"), a company authorized to provide interexchange telecommunications services in Missouri¹, respectfully notifies the Missouri Public Service Commission ("Commission") that it has changed its name to Vodafone US Inc. ("VUSI").

Pursuant to Missouri Code of State Regulations section 240-2.062, VUSI provides the following information relating to its name change:

- A. Old name: Vodafone Global Enterprise Inc.
New name: Vodafone US Inc.
- B. A copy of the Company's registration of the name change with the Missouri Secretary of State is appended.
- C. The Company has no customers in Missouri to be notified regarding this change.

- E. VUSI has reviewed its contacts as listed in the Commission's electronic filing and information system (EFIS) and determined that, with the exception of the new name, its listing is current. The Company's understanding is that, following Commission acknowledgement of the name change, its record in EFIS will be updated to reflect the new name.

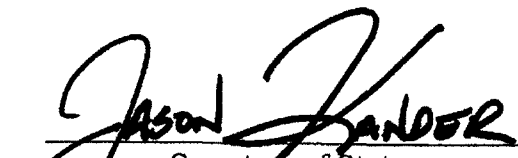
