On September 13, 2006, five individual intervenors, Ben F. Weir, Stan Temares, Cathy Orlor, Eugene Prather, and Benjamin D. Pugh, filed a motion requesting that the Commission arrange to have a regulatory law judge available to serve as a neutral moderator at the prehearing scheduled for September 20. The motion indicates that the parties are likely to have extensive discussions about the substance of Big Island Water & Sewer Company's application and suggests that a judge who is not otherwise involved in the case might be able to mediate those discussions.

The Commission agrees that another judge, who will not otherwise be involved in this case, may be able to mediate any disputes that may arise between the parties. The request will be granted.

IT IS ORDERED THAT:

1. A regulatory law judge who is not otherwise involved in this case will be present at the prehearing conference on September 20, 2006, for the purpose of mediating any disputes that may arise between the parties.
2. This order shall become effective on September 14, 2006.


