**INTERVENER'S FULL DISCLOSURE TO THE COMMISSION**

This submittal to the Commission, is to inform you that on Thursday, December 21, 2006, I called Ms. Pam Holstead. Ms. Holstead has identified herself to the PSC staff, as representing the majority of residents on Big Island for a proposed 393 utility corporation. However, Ms. Holstead has not provided any documentation to support her allegations of representation.

Because of Ms. Holstead's alleged representation of a majority, I called to inform Ms. Holstead of my opposition to the 393 utility corporations she has proposed. I also made full disclosure to Ms. Holstead, that I have contacted an attorney to represent me in litigation against the 393 utility corporations, should Ms. Holstead continue her pursuit of the transfer of my utility assets to a 393 corporation against my objection. I will not, accept the responsibilities and/or liabilities, financially and/or legally, that come with the 393 utility corporations.

The present water and sewer utility constructed, operated, managed, and administered by Folsom Ridge, LLC., currently has many issues that have been identified and documented. The issues have been reported to the DNR and the PSC, and have been documented as public record. In a meeting held on December 13, 2006, between interveners in case no. WA-2006-0480, and PSC staff, to discuss Ms. Holstead's proposed 393 utility corporations, the PSC staff admitted that by supporting Ms. Holstead's proposed 393 utility corporations, the staff could "make this case go away," although "this was not a resolve to the issues." My personal knowledge of the past and present issues with this utility, as documented to the Commission in the numerous pleadings and exhibits filed


in these cases, as well as the initial formal complaints and attachments submitted to the Commission, leaves me with no alternative but to pursue litigation, if the Commission allows the 393 corporations to provide utility service, and not regulate this utility. The PSC staff also stated to the complainants and interveners, that the Commission would not upon regulation, appoint a receiver to operate, manage, and administer the utility on Big Island as has been requested to the Commission in these cases by the complainants and interveners. The PSC staff said that if the interveners were opposed to the 393 corporations, that they should modify their rebuttal testimonies to allow the Application case to move forward with the certification of Folsom Ridge, now Big Island Water and Sewer Company as applicant.

At this meeting, the interveners asked the PSC staff, what documentation was supplied by Ms. Holstead, to the PSC staff, to confirm her majority of support she was representing. Mr. Dale Johansen, answered for the staff, saying, "Why would we feel that necessary?" Although Ms. Holstead had not provided residents with any information regarding a 393 utility corporation, such as by-laws and state statutes, Ms. Holstead had provided the staff with a copy of the corporations by-laws. Intervenors asked for a copy of the 393 corporations' by-laws, but Mr. Johansen refused to allow us to have a copy. Therefore, as of the date of this submittal to the Commission, neither interveners, complainants, or Big Island residents, have received a copy of the by-laws.

My feelings thus far, regarding the 393 utility corporations, is that information is not being made public, and intentionally being withheld. Not all residents have even been made aware of the proposed 393 utility corporations, but all will be affected in their approval.

Any explanation from the Commission, that can be given as to what seems to be a forced resolution to the claims in these cases, would be very greatly appreciated.
