**SPRINT MISSOURI, INC. REQUEST TO CANCEL PRE-HEARING CONFERENCE**


COMES NOW, Sprint Missouri, Inc d/b/a Sprint (hereinafter "Sprint"), and in support of this request states as follows:

In this case, Sprint has asked the Commission to approve a voluntarily negotiated interconnection agreement entered into between Sprint and ICG Telecom Group, Inc. pursuant to 47 U.S.C 252. ICG was made a party. A hearing is not required in this case and Staff has issued a recommendation to approve the interconnection agreement.

The Missouri Independent Telephone Company Group ("MITCG"), and the Small Telephone Company Group ("STCG"), have filed to intervene. In their Motions to Intervene, they request a hearing. Sprint, ICG and Staff all oppose intervention for reasons stated in the pleadings filed July 2, 2003. As the Commission has not ruled on the motions to intervene, no party to the proceeding has requested a hearing. Therefore, Sprint requests that the Pre-hearing set in this case for July 11, 2003 be canceled.


