## **ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH COMMISSION ORDER**

On October 13,<sup>1</sup> Noel Water Company ("NWC") filed tariff sheets pursuant to the Commission's October 7 Order Approving Company/Staff Disposition Agreement, Rejecting Tariffs and Authorizing Tariff Filing ("Order"). On October 15, after reviewing the tariff filings, the Commission's Staff recommended that the Commission approve the submitted tariff sheets. No other party filed a response or objection to approval of the tariff sheets. The Commission has reviewed the tariff filings, and Staff's verified recommendation, and finds that NWC's tariff sheets are in compliance with the Commission's order approving the disposition agreement.
