ORDER DIRECTING FILING AND SETTING DEADLINE

The Missouri Public Service Commission is directing Staff to file a recommendation on, and setting a deadline for responses to, the *Motion for Approval of Triumph Addendum No. 2* (“the motion”).

On June 30, 2010, MAWC filed the motion. The motion asks the Commission to approve the motion’s appendix 1, titled “Addendum No. 2.” Addendum No. 2, MAWC alleges, incorporates certain terms of the *Stipulation and Agreement*. The terms of the *Stipulation and Agreement* referred to an agreement that, MAWC represents, is embodied in Addendum No. 2, and constituted the basis for MAWC’s compliance tariffs. The compliance tariffs became effective, by Commission order upon contested case procedure, the day after the filing and the date of this order’s issuance.

Nevertheless, MAWC notes that the Commission may:

Whenever there shall be filed with the commission by any . . . water corporation or sewer corporation . . . any new form of contract or agreement . . . , the commission . . . after full hearing, whether completed before or after the . . . form of contract or agreement . . . goes into effect, the commission may make such order in reference to such . . . form of contract or agreement . . . as would be proper in a proceeding initiated

after the . . . form of contract or agreement . . . had become effective.[¹]

Therefore, the Commission elects to treat the motion under this file number rather than as a separate action. The Commission will set a deadline for any party's response to the motion and direct Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. Any party's response to the *Motion for Approval of Triumph Addendum No. 2* ("motion") shall be filed no later than July 15, 2010.
2. The Commission's staff shall file a recommendation as to the motion no later than July 30, 2010.
3. The Commission's Data Center shall keep this file open for any such response, such recommendation, and any Commission order.
4. This order shall become effective immediately upon issuance.
