## **ORDER OF CORRECTIONS**

Issue Date: October 5, 2010 Effective Date: October 5, 2010

The Commission is correcting its records as to the effective date of tariffs and correcting a clerical error in the *Report and Order*.

## a. Background

The Commission received tariff sheets related to sewer service ("original sewer tariffs"), to which the Commission assigned tracking nos. YS-2010-0311, YS-2010-0312, YS-2010-0313, and YS-2010-0314, and file no. SR-2010-0135, which the Commission later consolidated under this file number. The Commission suspended those tariffs until September 29, 2010. The *Stipulation and Agreement* addressed the original sewer tariffs by proposing provisions ("Appendix A") in lieu of the original sewer tariffs.

The Report and Order incorporated the Stipulation and Agreement and ordered the filing of new tariffs conforming to the Stipulation and Agreement. The Commission received tariff revision sheets ("revised sewer tariffs") and substitute tariff sheets ("substitute sewer tariffs"). The Commission received Staff's Recommendation as to Tariff Sheets Compliance ("Staff recommendation") favoring approval of the revised and

substitute tariffs. Accordingly, the Commission issued its *Order Approving Compliance Tariffs* approving the revised and substitute tariffs.

No party objected to the *Stipulation and Agreement*, no party filed a motion for reconsideration as to the *Report and Order*, no person filed any objection to the revised sewer tariffs, no person filed any objection to the substitute sewer tariffs, and no party filed a motion for rehearing on the *Order Approving Compliance Tariffs*.

#### b. Errors

Nevertheless, the *Report and Order* did not expressly reject the original sewer tariffs. Also, the Commission assigned new tracking numbers to the revised sewer tariffs and substitute sewer tariffs.<sup>[1]</sup> So when the suspension expired on September 29, 2010, the Commission's Data Center reported that the original sewer tariffs had taken effect by operation of law. That was not the intent of any party, nor of the Commission, as the *Stipulation and Agreement, Report and Order*, amended sewer tariffs, substitute sewer tariffs, Staff recommendation, and *Order Approving Compliance Tariffs* show. As those documents show, as of the *Stipulation and Agreement*, all parties abandoned the original sewer tariffs.

#### c. Corrections

In lieu of the original sewer tariffs, the *Order Approving Compliance Tariffs* approved the revised and substitute tariff sheets. To reflect the true intention of the parties and the Commission, the Commission will correct its error in reporting that the original sewer tariffs were effective. The Commission will also correct the *Report and*

Order by adding language—now for then—that will reflect the intent of the parties and the Commission when the Report and Order issued.

### THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center is ordered to correct its records as to the tariff sheets to which the Commission assigned tracking nos. YS-2010-0311, YS-2010-0312, YS-2010-0313, and YS-2010-0314 to show that such tariff sheets have never become effective.
- 2. The *Report and Order* under this file number is corrected to include the following language in ordered paragraph 2:

The tariff sheets to which the Commission assigned tracking nos. YS-2010-0311, YS-2010-0312, YS-2010-0313, and YS-2010-0314 are rejected.

3. This order is effective immediately on issuance.
