SECTION 1: FILING REQUIREMENTS

1.1 LETTER OF TRANSMITTAL

As required by Rule 22.080 (1) (A), the Letter of Transmittal is included as a cover letter at the beginning of this filing.

1.2 SUMMARY OF PRESS RELEASE

Rule 22.080 (1) (B) requires that if a press release related to the IRP filing is published, a copy of the release would be provided. Kansas City Power & Light (KCP&L) has chosen not to publish a press release and therefore has met the rule.

1.4 NARRATIVE SUMMARY AND EXECUTIVE APPROVAL

As required by Rule 22.080 (1) (D), the Executive Summary is included as Volume 1 of this IRP filing. Included under Section 5.1.5 of the Executive Summary is a letter signed by Mr. William Downey, President and CEO of Kansas City Power and Light Company. Inclusion of this signed letter addressing the IRP results and the planned Sustainable Resource Strategy (SRS) process serves as the approval required by Rule 22.080 (1) (D) and Rule 22.070 (10).

1.5 REQUEST FOR PROTECTIVE ORDER

Rule 22.080 (1) (E) requires the inclusion of a request for protective order for highly confidential and proprietary information. The letter of transmittal discussed above in Section 1.1 discusses the application of Rule 4 CSR 240-2.135 for protection of highly confidential and proprietary information. Based on this rule, a separate request for an order of protection is no longer necessary and is not included in this filing.

1.6 TARIFF SHEETS

Tariff sheets for DSM programs as required by 22.080 (1) (F), are not required at the time of this filing. Tariff sheets will be developed and submitted in the future as needed prior to program roll-outs. The proposed programs included in the preferred resource plan of this filing will be further evaluated and developed through the collaborative SRS process discussed in Volume 1, Executive Summary prior to development of tariff sheets.

1.7 REQUEST FOR NONTRADITIONAL ACCOUNTING PROCEDURES

KCP&L is not requesting nontraditional accounting procedures at this time, as discussed in Rule 22.080 (2).

1.8 FILING SCHEDULE

As required by 22.080 (3), KCP&L is filing this IRP on or before August 5, 2008.

1.9 DATA PRESERVATION

As required by 22.080 (7), KCP&L will preserve at least one copy of the IRP filing and all supporting information for at least ten (10) years after the filing date of this IRP.
