## STAFF NOTICE AND RESPONSE TO PUBLIC COUNSEL'S REQUEST FOR IMMEDIATE ORDER AND MOTION FOR EXPEDITED TREATMENT

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its

Notice And Response to Public Counsel's Request For Immediate Order And Motion For

Expedited Treatment, states as follows:

- 1. On July 13, 2006, the Office of Public Counsel filed its Request For Immediate Order And Motion For Expedited Treatment (Request) in the above-captioned case. In its Request, Public Counsel asks that the Commission A) immediately order Hickory Hills to continue chlorination; B) immediately order Hickory Hills to immediately provide notice to its customers that it has not and will not discontinue chlorination; and C) offer the opportunity for hearing as soon as practicable after the issuance of such order.
- 2. Staff believe's that Public Counsel's *Request* is unnecessary for the following reasons:
  - A) Mr. Randy Clifford of Hickory Hills Water & Sewer Company has informed James M. Russo of the Commission's Water & Sewer Department that he is presently chlorinating the water system and intends to continue chlorination of the system. (See

attached Affidavit of James M. Russo attached hereto as Appendix A and incorporated by reference herein.)

B) The Staff intends to mail notice to the customers of Hickory Hills Water & Sewer Company informing customers that Mr. Clifford has not stopped chlorinating the system and will continue chlorination of the system. The Staff intends to mail this notice not later than July 21, 2006.

WHEREFORE, for the foregoing reasons, the Staff respectfully requests that the Commission dismiss Public Counsel's Request.
