**ORDER APPROVING TARIFF SHEETS**  
**IN COMPLIANCE WITH COMMISSION ORDER**

Syllabus: This order approves the tariff sheets filed by Hickory Hills Water & Sewer Company in compliance with an order of the Missouri Public Service Commission order.

On June 15, 2006, the Commission issued its Report and Order in this case directing Hickory Hills Water & Sewer Company ("Company") to file revised tariff provisions to decrease its annual water system operating revenues by \$840 and authorized the Company to file revised tariff provisions to increase its annual sewer system operating revenues by \$2,413.

On November 1, 2006, Gary V. Cover, the Commission-appointed interim receiver for the Company, filed a revised water rate tariff sheet and a revised sewer rate tariff sheet intended to be in compliance with the Commission's June 15, 2006 Report and Order. The subject tariff sheets bear an effective date of December 1, 2006, and were assigned Tariff file Nos. YW-2007-0303 and YS-2007-0304.

On November 2, 2006, the Commission's Staff filed its Recommendation for Approval of Tariff Sheets. In its recommendation Staff indicated that it had reviewed the

proposed tariff sheets and found them to be in compliance with the Commission's June 15th Report and Order. Staff recommends that the pending tariff sheets be approved to become effective on December 1, 2006.

The Commission has reviewed the Company's tariff filing and Staff's recommendation and finds that the tariff sheets are in compliance with the Commission's June 15th Report and Order and shall be approved as ordered below.

1. Tariff No. YW-2007-0303 as submitted on November 1, 2006, is hereby approved for service to be rendered on or after December 1, 2006. The water service tariff sheet approved is:
