USCOC of Greater Missouri, LLC d/b/a U.S. Cellular ("U.S. Cellular" or "Company") states the following:

1. At the hearing conducted on December 18-19, 2006, in the above-referenced matter, Exhibit 34 was reserved for a late-filed exhibit of a map of the cell sites and associated coverage that are planned by the end of 2007 in the absence of high-cost support. Tr. at pp. 742-45.

2. Attached as Exhibit 34 is a map of the cell sites and associated coverage expected to be in place by the end of 2007 in the absence of high-cost support. Specifically, Exhibit 34 shows the locations and coverage of (a) cell sites that were constructed in 2006 after the maps submitted in the August 2006 Compliance Filing were prepared; and (b) cell sites that are planned for construction for 2007. The resulting map provides a picture of U.S. Cellular's expected infrastructure build-out at the end of 2007 in the absence of high-cost support, as requested at the hearing. Exhibit 34 is designated Proprietary by the Company.

3. As U.S. Cellular has noted with regard to maps it has previously submitted in this proceeding, the parameters of the planned construction shown on the attached map are subject to change in response to consumer demand, network engineering requirements, available revenues, and other factors. Additionally, because of limitations inherent in the use of maps to simulate

predicted signal coverage to the consumer, some areas that appear to be solidly covered may in fact have significant areas with weak or nonexistent signal coverage.

4. As requested by the Commission, U.S. Cellular will provide a clear plastic overlay of Exhibit 34 to the Commission so that the Commission can compare it to the other large maps which were utilized at the hearing.
