10 11	Q. Please state your name and business address.
12	A. My name is John Van Eschen. My business address is 200 Madison Street
13	Jefferson City, Missouri 65102-0360.
14	Q. By whom are you employed?
15	A. I am employed by the Missouri Public Service Commission (Commission) as
16	Manager of the Telecommunications Department.
17	Q. What are your duties and responsibilities?
18	A. I direct and coordinate activities and work within the Telecommunication
19	Department. More specifically, I assist in the development of Commission Staff
20	recommendations in response to tariff filings, certificate applications, interconnection
21	agreements, formal complaints, telecommunications company transactions, and other matters
22	pending before the Commission. I also assist in the development of rulemakings, comments
23	before the Federal Communications Commission, and the analysis of proposed legislation
24	pertaining to telecommunications regulation. My duties also involve overseeing the
25	monitoring of quality of service provided by basic local telecommunications companies.
26	have led roundtable meetings, groups and workshops intended to study and discuss various
27	issues related to the telecommunications industry.
28	Q. What is your educational background?

- A. I have a Bachelor of Arts degree in Psychology from the University of Iowa and have a Master of Arts degree in Economics from Kansas State University.
 - Q. Have you previously testified before this Commission?
- A. Yes. I have been employed by the Commission since 1984 and have filed testimony in a variety of cases before the Commission. In particular, I testified on Staff's behalf in Case Nos. TO-2006-0102 and TO-2006-0093, AT&T's 60-day and 30-day petitions where competitive classification was granted to AT&T exchanges.

EXECUTIVE SUMMARY

- Q. Please provide an executive summary of your testimony.
- A. AT&T should be allowed to retain competitive classification in all currently classified competitive exchanges.
 - Q. What is the purpose of your rebuttal testimony?
- A. In response to the direct testimony of Office of the Public Counsel witness Ms. Barbara Meisenheimer, I will offer more detailed information concerning the level of competition for basic local telecommunications service in Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri's (AT&T's) exchanges granted competitive classification under the 60-day track in Case No. TO-2006-0102. In addition, I plan to provide more detailed information regarding AT&T's rate changes for basic local telecommunications service. I also will file revised Appendices A, B, C and D attached to Staff's Report previously filed in this case; however first I will provide some background information for this proceeding.
 - Q. Why did the Commission Staff initiate this case?
- A. According to Section 392.245.5(6), "...The commission shall, at least every two years, or where an incumbent local exchange telecommunications company increases

rates for basic local telecommunications services in an exchange classified as competitive, review those exchanges where an incumbent local exchange carrier's services have been classified as competitive, to determine if the conditions of this subsection for competitive classification continue to exist in the exchange..." The Commission Staff filed a Staff Report in August 2006 after AT&T increased rates for basic local telecommunications services in many of its competitively classified exchanges.

- Q. What is your understanding of the main issue in this proceeding?
- A. According to the Joint Motion to Establish Procedural Schedule and Stipulation as to 30-Day Track Exchanges and the direct testimony of Office of the Public Counsel witness Barb Meisenheimer, the remaining issue concerns the appropriateness of maintaining competitive classification for the exchanges granted competitive status under the 60-day track.
 - Q. How many AT&T exchanges have competitive classification?
- A. AT&T has 77 exchanges with competitive classification for residential services and 75 exchanges have competitive classification for business services. Competitive classification was granted to these AT&T exchanges in two proceedings. Case No. TO-2006-0093 pertains to AT&T's 30-day petition and the Commission granted competitive classification to 26 exchanges for residential services and 45 exchanges for business services. Case No. TO-2006-0102 concerns AT&T's 60-day petition and the Commission granted competitive classification to 51 exchanges for residential services and 30 exchanges for business services.
- Q. What criteria must be met for an exchange to continue to qualify for competitive status?

- A. Missouri statutes allow an incumbent local telephone company to petition for competitive classification within an exchange under two different tracks: a 30-day track and a 60-day track. The basic criteria is the same for both tracks in the sense an exchange can qualify for competitive status if it can be demonstrated that at least two nonaffiliated entities in addition to the incumbent local exchange company are providing basic local telecommunications service within the exchange. The statute does place limitations on the type of competition that can be counted under the 30-day track. The conditions that originally qualified an exchange for competition must continue to exist when the Commission completes a review to determine if competition continues to exist.
- Q. What qualifying criterion was established for competitive status under the 60-day track in Case No. TO-2006-0102?
- A. The basic qualifying criterion of having two nonaffiliated local voice service providers is still applicable but the 60-day track allows the incumbent local telephone company to petition the Commission for competitive classification within an exchange based on competition from any entity providing local voice service in whole or in part by using its own telecommunications facilities or other facilities or the telecommunications facilities or other facilities of a third party, including those of the incumbent local exchange company as well as providers that rely on an unaffiliated third-party Internet service. The Commission's decision in Case No. TO-2006-0102 recognized local voice service competition from non-affiliated entities that included wireless carriers, VoIP providers using an unaffiliated cable television company's broadband network, and competitive local exchange carriers (CLECs) providing service on either a full facility, partial facility or other resale basis whereby other

21 22 resale is defined as arrangements where the CLEC uses UNE-P or similar commercial wholesale service from AT&T.

- Q. Please distinguish the terms full facility basis, partial facility basis and other resale.
- Full facility basis refers to CLECs providing service where the CLEC or its A. affiliate owns the switch and the lines providing local voice service to the customer. Partial facility basis refers to CLECs providing service where the CLEC or its affiliate owns either the switch or the lines. Other resale basis refers to CLECs providing service where the CLEC leases facilities from the incumbent local telephone company at a negotiated or arbitrated rate or through an arrangement purchased via a commercial agreement. Other resale basis can be distinguished from a pure resale basis. Pure resale is where the CLEC is essentially offering the incumbent telephone company's service under the CLEC's name and rates. The rates a CLEC pays the incumbent local telephone company for a pure resale arrangement are simply discounted retail rates of the incumbent telephone company.
- Q. Do you wish to make any changes to the Staff Report previously filed in this case?
- A. Yes. I am revising Appendices A, B, C, and D as attached to Staff's Report. Attached to my testimony are Schedules 1 and 2 which revise Appendix A and Appendix B of the Staff Report. These Schedules summarize the number of lines and the number of competitive local exchange carriers (CLECs) in AT&T's exchanges granted competitive status under the 60 day track. Schedule 1 relates to AT&T's 51 exchanges where competitive classification was granted for residential services under the 60-day track while Schedule 2

pertains to AT&T's 30 exchanges where competitive classification was granted for business services under the 60-day track.

Schedules 3 and 4 are revised versions of Appendices C and D as attached to Staff's Report summarizing the number of lines and the number of CLECs in AT&T's exchanges granted competitive status under the 30 day track. Schedule 3 relates to AT&T's 45 exchanges where competitive classification was granted for business services under the 30day track while Schedule 4 pertains to AT&T's 26 exchanges where competitive classification was granted for residential services under the 30-day track.

- Q. Explain what revisions were made to the Appendices contained in Staff's Report.
- Access lines associated with the AT&T affiliates of AT&T Communications A. Southwest, TCG Kansas City and TCG St. Louis have been removed. Access lines associated with three CLECs solely providing prepaid service were inadvertently included in the list and have since been removed. The three prepaid service providers are FamilyTel, Bulls Eye and Ren-Tel. It should be noted that AT&T affiliates and prepaid providers were not included in the data the Commission reviewed when it originally granted AT&T competitive classification in 2005. The column entitled "Rate Change" was also removed.
- Q. What is the source for CLEC access line quantities in AT&T competitively classified exchanges?
- A. This information is based on 2005 Annual Reports submitted by companies providing basic local telecommunications services. A carrier is required to provide line counts on a per exchange basis indicating lines being served as of December 31st of that year. A carrier is expected to report access lines based on how the carrier is serving the lines within

an exchange such as on a full facility, partial facility, other resale or pure resale basis. In this instance our most recent Annual Reports on file for companies were submitted on April 15, 2006 and reflect lines served as of December 31, 2005. When the Commission granted competitive status to various AT&T exchanges in the Fall of 2005, the Commission was relying on 2004 Annual Reports. The 2004 Annual Reports reflect lines served as of December 31, 2004.

- Q. Do you wish to expand or supplement any of the information contained in Staff's Report?
- A. Yes. I will offer four additional schedules (Schedules 5, 6, 7 and 8) that attempt to provide comparisons of how CLEC activity has changed in each of the 60-day track exchanges. This comparison will quantify total CLEC lines and the total number of CLEC providers in each exchange based on the 2004 Annual Report versus the 2005 Annual Report. Schedule 5 is a summary of this comparison for AT&T's residential 60-day competitive exchanges. Schedule 6 is a similar summary for AT&T's business 60-day competitive exchanges.
- Q. How has CLEC activity changed for AT&T's residential 60-day competitive exchanges?
- A. Schedule 5 shows that for AT&T's 51 residential competitive exchanges the total number of CLEC lines in these exchanges decreased by 1,542 lines for CLECs providing service either on a full facility, partial facility or other resale basis. CLEC line totals within these 51 exchanges were 19,212 lines using 2004 Annual Report data; however, CLEC lines totaled 17,714 lines based on 2005 Annual Report data.

On an exchange-specific basis, 37 out of the 51 exchanges experienced a decrease in the total number of CLEC lines within an exchange. In contrast 14 out of the 51 exchanges experienced an increase in the total number CLEC lines. In terms of the total number of CLECs that are offering service on a full facility, partial facility or other resale arrangement in these exchanges, 21 out of the 51 exchanges saw a decrease in the total number of CLECs providing service within the exchange, 19 exchanges saw an increase in the total number of CLECs, and 11 exchanges maintained the same number of CLECs.

- Q. How has CLEC activity changed for AT&T's business 60-day competitive exchanges?
- A. Schedule 6 shows that for AT&T's 30 exchanges with competitive classification for business services, the total number of CLEC lines in these exchanges decreased by 126 lines for CLECs providing service either on a full facility, partial facility or other resale basis. CLEC line totals within these 30 exchanges were 3,626 lines using 2004 Annual Report data; however, CLEC lines totaled 3,500 lines based on 2005 Annual Report data.

On an exchange-specific basis, 16 out of the 30 exchanges experienced a decrease in the total number of CLEC lines within an exchange. In contrast 13 out of the 30 exchanges experienced an increase in the total number CLEC lines. In terms of the total number of CLECs that are offering service on a full facility, partial facility or other resale arrangement in these exchanges, 16 out of the 30 exchanges saw a decrease in the total number of CLECs providing service within the exchange, 9 exchanges saw an increase in the total number of CLECs, and 5 exchanges maintained the same number of CLECs.

Q. What other aspects of Schedules 5 and 6 do you wish to point out?

A. Based on 2005 Annual Report data each of the 51 AT&T residential 60-day competitive exchanges and each of the 30 AT&T business 60-day competitive exchanges have 3 or more CLECs providing service on a full facility, partial facility or other resale basis.

- Q. Why is it noteworthy to point out that these exchanges have 3 or more CLECs providing such service on this basis?
- As previously discussed, according to Section 392.245.5 the basic qualifying A. criteria for competitive status is the presence of at least two nonaffiliated entities in addition to the incumbent local exchange company as providing basic local telecommunications service to customers within the exchange. Simply looking at CLEC activity, the evidence indicates this criteria is met. This observation may minimize Ms. Meisenheimer's criticisms about wireless competition for AT&T's 60-day competitive exchanges since a wireless competitor is not needed to satisfy the required number of competitors offering service in any exchange.
 - Q. Please explain Schedules 7 and 8.
- Schedules 7 and 8 are simply a more detailed list of the specific CLECs used A. to compile the information in all of the previously described schedules. These schedules list each CLEC that was/is providing basic local telecommunications service on a full facility, partial facility or other resale basis based on 2004 and 2005 Annual Reports. Each CLEC's total number of lines within the exchange is shown based on data from the CLEC's 2004 and 2005 Annual Reports. These schedules footnote the access lines served by any CLEC who is providing basic local telecommunications services on either a full facility or partial facility

O. If the remaining exchanges as listed above do not have a CLEC providing service on a full facility or partial facility basis, can the exchange still qualify for competitive classification?

A. Yes. In Case No. TO-2006-0102, AT&T's 60-day proceeding, the Commission determined an exchange can qualify for competitive classification based on the presence of a competitor providing service by leasing facilities from the underlying carrier through an interconnection agreement or a commercial agreement. As previously discussed, I refer to such arrangements in Staff's Report and this testimony as an "other resale" arrangement.

Q. Do you have any response to Ms. Meisenheimer's statements concerning AT&T's rate changes?

A. Yes. I am providing additional information regarding AT&T's rate adjustments for basic local telecommunications service. Specifically I want to identify the rate levels and how these rates have changed over time in order to place some perspective on AT&T's rate adjustments during the past year. Schedules 9 and 10 identify the respective residential and business rate levels for AT&T's basic local telecommunications service at the time of competitive classification and subsequent rate adjustments. Schedules 11 and 12 identify the respective residential and business basic local telecommunications service rates since 1985 for residential rates and 1986 for business rates.

- Q. What points do you wish to make regarding these schedules?
- A. Some rates have decreased since competitive classification was granted. A second point is that AT&T's current rates for basic local telecommunications service are similar to the rates applied by AT&T over 20 years ago.

AT&T has been granted competitive status for 21 exchanges³ in Rate Group A for residential services and 19 exchanges⁴ in Rate Group A for business services. AT&T applies the same rates to all Rate Group A exchanges regardless of whether an exchange has competitive classification. Schedules 9 and 10 show flat rate, one-party residential and business basic local telecommunications service rates for Rate Group A exchanges have decreased since AT&T was granted competitive status. For example, the monthly rate for Rate Group A residential flat rate one-party service was \$7.29 prior to competitive classification and is currently is \$7.15. The corresponding monthly rate for business flat rate one-party basic local telecommunications service in Rate Group A exchanges was \$16.25 prior to competitive classification and is currently \$15.93. In this respect, this information may conflict with Ms. Meisenheimer's statement on page 9, lines 18-21, where she was unable to identify any basic local services in any competitive exchanges where AT&T lowered the price after it was granted competitive status in either the 30-day or 60-day petitions. A second point is that Schedules 7 and 8 indicate flat rate, single party rates in effect for AT&T's four rate groups during the past 20 years have remained relatively stable. For example simply comparing the rates of over 20 years ago with today's rates, the overall rate changes range from -\$.65 to +\$.95 for residential rates and from -\$.1.17 to +\$4.20 for

business rates. This information is illustrated in the following table:

³ Among these 21 Rate Group A exchanges, 15 exchanges were granted competitive status for residential services in the 60-day proceeding (Antonia, Archie, Ash Grove, Billings, Clever, Farley, Grain Valley, Gray Summit, Herculaneum-Pevely, Hillsboro, Marionville, Portage Des Sioux, San Antonio, Walnut Grove, and Ware) and 6 exchanges were granted competitive status for residential services in the 30-day proceeding (Advance, Bell City, Delta, Pocahontas-New Wells, Smithville, and Wyatt).

17 18 Q. Do you have any comments about Ms. Meisenheimer's criticisms concerning the lack of wireless provider information for this review?

A. As noted in Staff's Report, Staff limited its review to CLEC activity. Staff is unaware of any conditions changing the presence of a qualifying wireless carrier in any AT&T competitive exchange. Staff is unaware of any wireless provider withdrawing service from any exchange. In addition Staff is unaware of any changed conditions that would make it a toll call to reach a wireless subscriber residing in the same exchange. Moreover, no specific evidence has been presented suggesting any wireless carrier's service has changed to no longer allow an AT&T competitively classified exchange to qualify for competitive status. Staff has made a very limited independent analysis of whether wireless providers have been directly assigned telephone numbers within the local calling area of each competitive 60-day exchange. Based on information released by NeuStar, the administrator for telephone numbers within North America, twelve exchanges⁶ fail to show nonaffiliated wireless providers with directly assigned telephone numbers in the exchange's local calling area. Nevertheless a wireless provider may indirectly be assigned telephone numbers in these exchanges through Type 1 connections. Type 1 connections allow a wireless provider to indirectly receive telephone numbers through the incumbent local telephone company. In

⁵ All of AT&T's exchanges in Rate Groups B, C, and D have competitive status for both residential and business services while some of the exchanges in Rate Group A have been granted competitive status for either residential and/or business services.

⁶ The twelve exchanges are: Ash Grove, Billings, Clever, Farley, Grain Valley, Greenwood, Linn, Marionville, Montgomery City, Richmond, St. Clair, and Walnut Grove.

such situations, NeuStar's information identifies the incumbent local telephone company rather than the wireless carrier as the entity assigned the telephone numbers. At this time Staff has been unable to verify if AT&T has Type 1 connections with any nonaffiliated wireless carrier in the local calling scopes of these twelve exchanges.

Despite this lack of verification that a nonaffiliated wireless provider is providing service in 60-day competitive exchanges such verification is unnecessary. As previously discussed, for all of AT&T's exchanges granted competitive status under the 60-day track, at least 3 or more qualifying CLECs are providing service in each 60-day competitive exchange. Such evidence would allow a 60-day competitive exchange to qualify for competitive status regardless of whether wireless providers are providing service in the exchange.

- Q. Do you have any additional comments?
- A. Yes. Schedule 13 attempts to provide a brief description of the CLECs providing service in AT&T's competitively classified exchanges. This schedule provides basic information on how the CLEC provides service, when the CLEC was authorized to offer service in Missouri, the case number for granting the CLEC a certificate of service authority, and any other noteworthy facts regarding the CLEC's operations.
 - Q. What is your recommendation for the Commission in this proceeding?
- A. I recommend the Commission retain competitive classification for all AT&T exchanges with competitive classification.
 - Q. Does this conclude your testimony?
 - A. Yes, it does.
