ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING
REQUESTS TO INTERVENE, AND ESTABLISHING TIME
FOR FILING RECOMMENDATIONS

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene and for the filing of recommendations.

On June 13, 2006, MCI Communications Services, Inc., d/b/a Verizon Business Services, filed an application under 47 C.F.R. 52.15(g)(3)(iv) requesting that the Commission review and reverse a decision of the North American Numbering Plan Administrator, NeuStar, Inc., to withhold certain numbering resources from Verizon in the form of two blocks of contiguous numbers to meet the needs of a new customer in the 314 NPA. Verizon's application included a motion for expedited treatment.

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a

copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and establish a date by which any other party wishing to respond must file a recommendation.

IT IS THEREFORE ORDERED:

1. That the Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.

2. That any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than June 21, 2006, with:
