ORDER GRANTING EXPEDITED TREATMENT AND OVERTURNING NORTH AMERICAN NUMBERING PLAN ADMINISTRATOR'S DECISION

Issue Date: June 9, 2010 Effective Date: June 11, 2010

On May 27, 2010, Southwestern Bell Telephone Company d/b/a AT&T Missouri, filed an Application and Motion for Expedited Treatment requesting that the Missouri Public Service Commission review and reverse a decision of the North American Numbering Plan Administrator (NANPA), NeuStar, Inc., of AT&T Missouri's application to obtain one block of one thousand numbers from which 800 consecutive numbers may be drawn within (1) the 636 NPA, (2) the Washington rate center, and (3) an XXXX range of 1000-1999, 2000-2999, 3000-3999 or 4000-4999. The additional numbers are needed in order to meet the needs of Parker Hannifin, which is adding Direct Inward Dial for its staff and is purchasing new telephone, voicemail and ACD systems.

On June 3, 2010, the Staff of the Commission filed its Staff Recommendation. No other applications to intervene, requests for hearing, or recommendations have been filed.

Staff explained that AT&T Missouri does not have one block of one thousand numbers from which 800 consecutive numbers may be drawn within (1) the 636 NPA, (2) the Washington rate center, and (3) an XXXX range requested to meet this customer's needs. Thus, even though AT&T Missouri's utilization level is 69% and is below the required utilization level of 75% and the months to exhaust is 26 months, which is above the required 6 months, Staff believes AT&T Missouri has demonstrated a verifiable need for one block of one thousand numbers. Staff recommended the Commission grant AT&T Missouri's request.

The Commission has the authority to overturn NANPA's decision to withhold numbering resources from a carrier pursuant to 47 C.F.R. §52.15(g)(4), which states in part, "The state commission also may overturn the NANPA's decision to withhold numbering resources from the carrier based on its determination that the carrier has demonstrated a verifiable need for numbering resources and has exhausted all other available remedies."

Based on AT&T Missouri's application and the Staff's recommendation, the Commission finds that AT&T Missouri has demonstrated a verifiable need for numbering resources and has exhausted all other available remedies. The Commission overturns NANPA's decision and approves AT&T Missouri's request for one block of one-thousand telephone numbers as listed above.

THE COMMISSION ORDERS THAT:

1. Southwestern Bell Telephone Company d/b/a AT&T Missouri's Motion for

Expedited Treatment is granted.

2. The North American Numbering Plan Administrator's decision to withhold

numbering resources from Southwestern Bell Telephone Company d/b/a AT&T Missouri, is

overturned.

3. Southwestern Bell Telephone Company d/b/a AT&T Missouri's request to receive

one block of one thousand numbers within (1) the 636 NPA, (2) the Washington rate

center, and (3) an XXXX range of 1000-1999, 2000-2999, 3000-3999 or 4000-4999, is

granted.

4. This order shall become effective on June 11, 2010.

5. This file may be closed on June 12, 2010.
