STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

- 1, On June 27, 2008, STi Prepaid, LLC and Sprint Communications Company, L.P. filed a joint application for authority to transfer to STi Prepaid all of Sprints assets related to the provision of prepaid calling card services.
- 2. On August 12, 2008, STi submitted tariff sheets (Tariff File No. YX-2009-0114) to amend its tariff to add Sprint's prepaid calling card service plans to its tariff. The tariff sheets bear a proposed effective date of September 11, 2008. STi submitted substituted sheets on August 13, 2008.
- 3. In the attached Memorandum, labeled Appendix A, the Staff recommends approval of the transfer. The transfer of assets is governed by Section 392.300 RSMo (2000). Applicable case law provides that the Commission may "not withhold its approval of the disposition of assets unless it can be shown that such disposition is detrimental to the public interest." *State ex rel. Fee Fee Trunk Sewer, Inc. v. Litz*, 596 S.W. 2d 466, 468 (Mo. App. E.D. 1980), citing to *State ex rel. City of St. Louis v. Public Serv. Comm'n of Mo.*, 73 S.W. 2d 392, 400 (Mo. banc 1934).
- 4. The Staff agrees with STi that customer notice is not required in this case because Sprint's prepaid calling card services do not have a dedicated customer base. The Application

states that a user of a Sprint-branded card that calls the toll-free access number and enters the PIN to make a prepaid call will be informed that STi and not Sprint is now the service provider.

WHEREFORE, the Staff recommends the Commission approve the transfer of assets and approve STi's tariff sheets effective September 11, 2008.
