## **ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH COMMISSION ORDER**

Issue Date: August 22, 2007

Effective Date: September 1, 2007

On August 13, 2007,<sup>1</sup> S. K. & M. Water and Sewer Company ("S. K. & M."), the Staff of the Missouri Public Service Commission ("Staff") and the Office of the Public Counsel ("OPC") filed a unanimous disposition agreement in this matter. On August 17, 2007, S. K. & M. filed a substitute tariff sheet to satisfy the terms and conditions of the agreement. The substitute tariff bears the same effective date as the originally filed tariffs, that being July 16. The Commission's suspension order issued on July 3, suspending the effective date of the original tariff until September 14, or until the Commission otherwise orders, applies to the substitute tariff.

On August 21, the Commission approved the unanimous disposition agreement and directed Staff to file a recommendation advising the Commission whether the substitute tariff sheet was in compliance with the approved disposition agreement. On August 22, Staff filed its recommendation. Staff finds the substitute tariff sheet accurately reflects the terms and conditions of the unanimous disposition agreement and recommends that the Commission approve the substitute tariff sheet, making it effective on September 1, 2007.

S. K. & M. had also submitted a second revised tariff sheet on May 31, which was in compliance with the original Company/Staff Disposition submitted in this matter.<sup>2</sup> This sheet set out various charges not associated with the general rate increase. This tariff sheet did not require any changes as a result of the unanimous disposition agreement and Staff further recommends its approval.

The Commission has reviewed S. K. & M.'s tariff sheets and Staff's recommendation, which are hereby admitted into evidence. Based upon these filings, the Commission finds that the tariff sheets shall be approved.

**IT IS ORDERED THAT:**

1. The following water service tariff sheets filed by S. K. & M. Water and Sewer Company in Case Number WR-2007-0460, and assigned Tariff File No. YW-2007-0864, are approved for service on or after September 1, 2007. The tariff sheets approved are:

1st Revised Sheet No. 6, Canceling Original Sheet No. 6

1st Revised Sheet No. 7, Canceling Original Sheet No. 7

2. This order shall become effective on September 1, 2007.
