#### STAFF RECOMMENDATION REGARDING TARIFF FILING

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its *Recommendation Regarding Tariff Filing* states the following to the Missouri Public Service Commission (Commission):

- 1. On October 23, 2008, the Commission received a Rate Increase Request Letter from Osage Water Company, Inc. (Osage or Company), requesting the Commission allow a 100% increase to its rates currently charged for water and sewer services.
- 2. On August 3, 2009, Staff, Osage, and the Office of Public Counsel (OPC) filed two separate Notice of Unanimous Agreement (collectively Unanimous Agreements) for both the small water company and small sewer company revenue increase request.
- 3. On August 12, 2009, the Commission issued its *Order Approving Unanimous Disposition Agreements and Authorizing Tariff Filings* (Order) approving the two Unanimous Agreements and authorizing Osage to file tariffs in compliance with the terms thereof.
- 4. On August 20, 2009, Osage filed revised tariff sheets with an effective date of September 19, 2009, designated tracking nos. YW-2010-0097 and YS-2010-0096 respectively.
- 5. James M. Russo, Rate and Tariff Examination Supervisor, has examined Osage's revised tariff sheets designated YW-2010-0097, P.S.C. MO No. 1, 4<sup>th</sup> Revised Sheet No. 5, Canceling 3<sup>rd</sup> Revised Sheet No. 5 and P.S.C. MO No. 1, 3<sup>rd</sup> Revised Sheet No. 6, Canceling 2<sup>nd</sup> Revised Sheet No. 6, and notes that the tariff revisions reflect the agreed-upon rate increase and

comply with the Commission's Order, and therefore should be allowed to take effect no later than September 19, 2009. See *Russo Affidavit*, attached hereto.

- 6. James M. Russo, Rate and Tariff Examination Supervisor, has examined Osage's revised tariff sheets designated YS-2010-0096, P.S.C. MO No. 1, 2<sup>nd</sup> Revised Sheet No. 10, Canceling 1<sup>st</sup> Revised Sheet No. 10 and P.S.C. MO No. 1, 1<sup>st</sup> Revised Sheet No. 11, Canceling Original Sheet No. 11, and notes that the tariff revisions reflect the agreed-upon rate increase and comply with the Commission's Order, and therefore should be allowed to take effect no later than September 19, 2009. See *Russo Affidavit*, attached hereto.
- 7. The Commission has the authority to approve the subject proposed tariff revisions in accordance with Sections 393.140 (11) and 393.150 RSMo (2000).

**WHEREFORE**, Staff respectfully recommends the Commission issue an order approving the following proposed revised tariff sheets currently pending under assigned no.

- 1) YW-2010-0083, to be effective no later than September 19, 2009:
  - P.S.C. MO No. 1, 4<sup>th</sup> Revised Sheet No. 5, Canceling 3<sup>rd</sup> Revised Sheet No. 5 and
  - P.S.C. MO No. 1, 3<sup>rd</sup> Revised Sheet No. 6, Canceling 2<sup>nd</sup> Revised Sheet No. 6; and
- 2) YS-2010-0096, to be effective no later than September 19, 2009:
  - P.S.C. MO No. 1,  $2^{nd}$  Revised Sheet No. 10, Canceling  $1^{st}$  Revised Sheet No. 10 and
  - P.S.C. MO No. 1, 1<sup>st</sup> Revised Sheet No. 11, Canceling Original Sheet No. 11.
