ORDER SUSPENDING TARIFF

Issue Date: July 1, 2009

Effective Date: July 1, 2009

This case began on October 23, 2008, when Osage Water Company filed a request for a rate increase under the Commission's small utility rate case procedure. In compliance with the Commission's regulation,¹ the Commission's Staff conducted an investigation of the utility's request. On May 21, 2009, Staff and Osage Water filed a disposition agreement regarding the utility's request for a rate increase. On May 26, Osage Water filed a tariff that would implement the disposition agreement. That tariff carries an effective date of July 10.

On June 26, following a local public hearing held on June 12, the Office of the Public Counsel filed a request for evidentiary hearing. Public Counsel disagrees with certain aspects of the disposition agreement, and requests a hearing regarding the inclusion in the utility's revenue requirement of interest payments on certain monetary judgments against the utility.

Commission rule 4 CSR 240-3.050(24) provides that the Commission is to issue an order resolving a small utility rate case no later than 11 months after the utility requests an

increase. Since Public Counsel has requested an evidentiary hearing, the Commission will suspend Osage Water's tariff until August 10. In order to bring this matter to a final resolution within the time allowed by the regulation, the Commission will also schedule a prehearing conference to discuss a procedural schedule.

THE COMMISSION ORDERS THAT:

1. The tariff sheets issued on May 26, 2009, by Osage Water Company and assigned Tariff No. YW-2009-0830, are suspended beyond July 10, 2009, to August 10, 2009, or until otherwise ordered by this Commission. The tariff sheets suspended are:


