**ORDER APPROVING COMPLIANCE TARIFFS**

Issue Date: June 22, 2010

Effective Date: July 1, 2010

The Missouri Public Service Commission is approving the tariff that Missouri American Water Company (“MAWC”) filed on June 18, 2010, as required by the Commission’s *Report and Order*, with substitute sheets filed on June 21, 2010 (“compliance tariff”). The compliance tariff sheets bear an effective date of on July 1, 2010 (“early effective date”). Ordinarily, MAWC cannot change the tariff “in force . . . and in effect”<sup>2</sup> without “thirty days’ notice to the commission and publication for thirty days [.]”<sup>3</sup> But the Commission may dispense with that 30-day requirement “for good cause shown [.]”<sup>4</sup>

On June 21, 2010, Staff filed its recommendation favoring approval of the compliance tariff. Staff’s recommendation also favors the early effective date and opines that the compliance tariff conforms to the Commission’s *Report and Order*. The *Report and Order* incorporated the provisions, deemed unanimous among the parties, of the *Stipulation and Agreement*, which proposed rejection of all tariffs then pending and the filing of new tariffs with the early effective date.

Therefore, the Commission independently finds and concludes that the compliance tariff conforms to the *Report and Order*, and that the parties have shown good cause for the early effective date, so the Commission will approve the compliance tariff.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets filed by Missouri-American Water Company on June 18, 2010, with substitute sheets filed on June 21, 2010, to which the Commission assigned tariff numbers YS-2010-0716, JS-2010-0718, YS-2010-0720, YW-2010-0721, YW-2010-0722, YW-2010-0723, YW-2010-0724, YW-2010-0725, and YW-2010-0726, are approved to become effective on July 1, 2010.
