STAFF RECOMMENDATION FOR APPROVAL OF TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and recommends that the Missouri Public Service Commission (“the Commission”) approve the substitute tariff sheet submitted in Case No. WR-2010-0304 and bearing Tariff Tracking No. YW-2011-0175. In support of this recommendation, Staff states as follows:

1. On October 1, 2010, Raytown Water Company (“Raytown”) filed a proposed tariff sheet (First Revised Sheet No. 9) in compliance with the terms of the *Company/Staff Agreement Regarding Disposition of Small Water Company Revenue Increase Request* (“the *Company/Staff Agreement*”) filed on September 27, 2010. This filing created Tariff Tracking No. YW-2011-0175.
2. On December 21, 2010, Raytown filed a substitute tariff sheet in compliance with the terms of the *Unanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request* (“the *Unanimous Agreement*”) filed on December 14, 2010.
3. The Commission has the authority to approve the proposed substitute tariff sheet pursuant to Section 393.140(11), RSMo (2000).
4. James M. Russo, Rate and Tariff Examination Supervisor, reviewed the substitute tariff sheet filed in Tracking No. YW-2011-0175, and states that to the best of his knowledge, information, and belief, the proposed sheet complies with the terms of the *Unanimous*

Agreement. See Affidavit of James M. Russo, attached hereto and incorporated by reference herein.

WHEREFORE, Staff recommends that the Commission issue an order approving *the Unanimous Agreement* filed in Case No. WR-2010-0304 and the tariff sheet pending in Tariff Tracking No. YW-2011-0175, to become effective January 31, 2011.


