STAFF’S SUPPORT OF TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its motion supporting the revised and substitute tariff filed by Rex Deffenderfer Enterprises, Inc. (RDE or Company), respectfully states to the Missouri Public Service Commission (Commission) the following:

1. On March 30, 2011, the Commission issued an *Order Approving Unanimous Disposition Agreement and Authorizing Tariff Filing (Order)*, which approved a Unanimous Disposition Agreement executed by Staff, RDE and the Office of the Public Counsel. The Commission authorized RDE to file tariffs in compliance with that agreement.

2. On April 1, 2011, RDE filed its revised tariff sheets. On April 11, 2011, RDE filed a substitute tariff sheet that removed duplicative and conflicting information from the revised tariff sheet filed on April 1. The tariff sheets reviewed by Staff for compliance with the Commission’s *Order* are:

Substitute tariff sheet PSC MO No. 1, 7th Revised Sheet No. 4, Cancelling PSC MO No. 1, 6th Revised Sheet No. 4 and;

Revised tariff sheet PSC MO No. 1, 1st Revised Sheet No. 4B, Cancelling PSC MO No. 1, Original Revised Sheet No. 4B.

3. Jim Russo, Rate & Tariff Examination Supervisor for Staff, has examined RDE’s revised and substitute tariff sheets as listed in paragraph 2, and states that to the best of his knowledge, information, and belief, the revised sheets comply with the Commission’s *Order*. See Attached *Affidavit Of James M. Russo*.

WHEREFORE, Staff supports the revised tariff sheets filed by RDE in Tariff File No. YW-2011-0501 and set out below, and states that these tariff sheets comply with the Commission's *Order*:


