**ORDER SUSPENDING TARIFF, DIRECTING NOTICE
AND SETTING INTERVENTION DEADLINE**

On June 22, 2011, Missouri American Water Company filed an application to change its Infrastructure System Replacement Surcharge. With its application, the company filed a proposed revised tariff sheet with an effective date of July 22. The Commission must therefore suspend the tariff to allow sufficient time for the Staff of the Commission to review Missouri-American's filing.

The Commission is required to act on the petition within 120 days. Consequently, any order the Commission issues must be effective no later than October 20. Although the Commission may decide this matter sooner, the Commission will suspend the company's tariff until October 20.

The Commission is also required to publish notice of the application. To that end, the Commission will require that notice be sent to those that may be interested and, in the order paragraphs below, set a deadline by which applications to intervene shall be filed.

THE COMMISSION ORDERS THAT:

1. The tariff sheet filed by Missouri-American Water Company, and assigned tariff number YW-2011-0644, is suspended until October 20, 2011. The sheet suspended

is: P.S.C. MO NO. 6, 12th Revised Sheet No. RT18.0, Cancelling 11th Revised Sheet No. RT18.0.

2. The Data Center of the Missouri Public Service Commission shall mail a copy of this notice to the County Commission for each of the counties in Missouri-American Water Company's service area and to the parties in the company's most recent rate case, Case No. WR-2010-0131.

3. The Information Office of the Missouri Public Service Commission shall make notice of this order available to the media serving Missouri-American Water Company's service area and to the member of the General Assembly representing Missouri-American's service area.

4. Applications to intervene shall be filed no later than July 8, 2011, and shall be filed with:
