


Dear Judge Dale:

I, Cathy Orlor, intervener in Case No. WA-2006-0480, in the public's best interests, as well as in the best interests of the other interveners, property owners, and future utility customers of Big Island, respectfully request that the Commission reject the application and deny certification of the Big Island Water and Sewer Company, Inc. to construct, install, own, operate, control, manage and maintain a water and sewer system located in an unincorporated area, known as Big Island, in Camden County Missouri. My request is supported by the documented evidence previously submitted, in the Formal Complaint case no. WC-2006-0082 et al, showing a 7 year history to the present, of numerous citations for DNR violations and repeat violations that required rework of construction, improper installation of both water and sewer lines, unauthorized operation of the utility system, and misrepresentation in unilaterally modifying and amending the previously "agreed to" agreements provided to homeowners for the solicitation of funds. In addition, many questions have been generated with the inconsistencies of both the application and feasibility study submitted by the Big Island Water and Sewer Company, Inc., and the requests from complainants and interveners for specific documents related to these, have not been honored. Furthermore, certification of the Big Island Water and Sewer Company would appear to generate a conflict of interests, due to the

same principles having control of both water and sewer services and the real estate developments in the area to be serviced.

As it is in the public's best interests, as well as in the best interests of the other interveners, property owners, and future utility customers of Big Island, I respectfully request that receivership of this utility be appointed to an independent company, (with no association or affiliation with Folsom Ridge, LLC. and its principles, or Big Island Water and Sewer Company, Inc., and its principles), to provide for the operation of the water and sewer systems under the guidelines of the Missouri Public Service Commission, until: (a.) the development project on Big Island by Folsom Ridge, LLC. and its principles is completed; (b.) civil court issues involving Folsom Ridge, LLC. and its principles and the utility are resolved. I am requesting a Formal Evidentiary Hearing to be held in this matter, the week of October 02, through October 06, 2006.
