ORDER APPROVING TARIFFS IN COMPLIANCE
WITH COMMISSION ORDER

Issue Date: December 5, 2005

Effective Date: December 16, 2005

On May 5, 2005, the Commission issued an order that expanded Emerald Pointe Utility Company's certificated area for water and sewer service. That order also directed Emerald Pointe to file revised tariff sheets consistent with its order before serving the new area.

On November 16, Emerald Pointe filed water tariff sheets P.S.C. MO. No. 1, First Revised Sheet No. 1, Original Sheets Nos. 2.1 and 3.1, effective December 16, 2005. The Commission assigned the water tariff sheets Tariff No. YW-2006-0378. Emerald Pointe filed a substitute sheet on November 30.

Also on November 16, Emerald Pointe filed sewer tariff sheets P.S.C. MO. No. 1, First Revised Sheet No. 1, Original Sheets Nos. 2.1 and 3.1, effective December 16, 2005. The Commission assigned the sewer tariff sheets Tariff No. YS-2006-0379.

On December 1, the Staff of the Commission filed its Recommendation. Staff stated that the tariff sheets comply with applicable statutes, and that Staff recommends that the Commission approve the tariff sheets.

The Commission has reviewed the tariff sheets and the Staff Recommendation. The Commission determines that the tariff sheets comply with the applicable statutes. The Commission will approve the tariff sheets.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets in Tariff No. YW-2006-0378 issued November 16, 2005, as substituted on November 30, 2005, are hereby approved to become effective on December 16, 2005:
