**STAFF RECOMMENDATION FOR APPROVAL OF TARIFFS**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and for its *Recommendation* respectfully states to the Missouri Public Service Commission (“Commission”) the following:

1. On December 1, 2009, Seges Partners Mobile Home Park (“Seges” or “Company”) filed proposed tariff sheets for water (YW-2010-0365) and sewer (YS-2010-0359) service pursuant to the Commission’s August 12, 2009 *Order Granting Certificates of Convenience and Necessity*.

2. Also on December 1, 2009, the Commission issued its *Amended Order Directing Filing (Amended Order)*, allowing until December 21, 2009, for the Staff to file a recommendation on whether the water and sewer tariff sheets comply with the Commission’s *Amended Order*.

3. Jerry Scheible, Staff Utility Regulatory Engineer, reviewed the tariff sheets filed in Tracking Nos. YW-2010-0365 and YS-2010-0359, and states that to the best of his knowledge, information, and belief, the proposed sheets comply with the Commission’s *Order Granting Certificates of Convenience and Necessity*. See the *Affidavit Of Jerry Scheible, P.E.*, attached hereto.

4. The Commission has the authority pursuant to Sections 393.140 (11) and 393.150 RSMo (2000) to approve the proposed tariff sheets.

**WHEREFORE**, the Staff recommends that the Missouri Public Service Commission issue an Order approving the tariff sheets pending in Tracking Nos. YW-2010-0365 and YS-2010-0359, with such tariffs having an effective date of December 31, 2009.
