### **STAFF RECOMMENDATION**

- 1. On May 12, 2009, Oakbrier Water Company, Inc. ("Company") filed an *Application and Motion to Expedite Application* to expand its current service territory in and around a subdivision known as Oakbrier Estates, in Butler County, Missouri.
- 2. On May 12, 2009, the Commission approved its *Order Granting Certificate of Convenience and Necessity* ("Order") granting the Company a certificate of convenience and necessity to provide water service to an expanded area in and around the subdivision known as Oakbrier Estates, in Butler County, Missouri. The *Order* was issued on June 3, 2009 and became effective on June 13, 2009.
- 3. On June 18, 2009, the Company submitted revised tariff sheets expanding the service territory as authorized by the Commission in this matter. The tariff sheets bare an effective date of July 18, 2009.
- 4. In the *Staff Recommendation*, attached hereto, as Exhibit A, Staff recommends that the Commission approve the tariff sheets to become effective on July 18, 2009.

5. The Company has a current rate case before the Commission, Case No. WR-2009-0229. Approval of these tariff sheets will not affect the pending rate case, or any other matter before the Commission.

**WHEREFORE**, Staff respectfully requests the Commission to issue an Order approving Oakbrier Water Company, Inc. tariff sheets to become effective on July 18, 2009.

On May 12, 2009, the Commission issued its <u>Order Granting Certificate of Convenience and Necessity</u> (Order) granting Oakbrier Water Co, Inc. (Oakbrier) a certificate of convenience and necessity (Certificate) to provide water service to an expanded area in and around a subdivision known as Oakbrier Estates, in Butler County, northeast of Poplar Bluff. The Order was issued on June 3, 2009 and became effective on June 13, 2009.

On June 18, 2009, Oakbrier submitted revised tariff sheets containing a map and written description, depicting its expanded service as authorized in this case. The tariff sheets bear an effective date of July 18, 2009.

As was noted in its *Staff Recommendation* filed in this case on May 27, 2009, the Staff reviewed Oakbrier's history regarding the submittal of its Commission annual reports and the payment of its Commission assessments, and found no deficiencies in this regard.
