SECOND JOINT STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff) by and through the undersigned counsel, and files this *Second Joint Status Report* with the Missouri Public Service Commission (Commission), respectfully stating the following:

1. On July 19, 2011, Lincoln County Sewer and Water, LLC (Lincoln County) filed with the Commission an *Application for Certificate of Convenience and Necessity Authorizing it to Own, Operate, Maintain, Control and Manage Water Systems in Lincoln County, Missouri*.
2. On April 17, 2012, the Commission issued an *Order Directing Status Reports (Order)* establishing a schedule for filing status reports, with the first one due May 1, 2012. This filing complies with that *Order*.
3. Representatives of Staff, Lincoln County and the Office of the Public Counsel (Public Counsel) (collectively referred to hereafter as “Parties”) have continued discussions and the exchange of information in this case since its last Joint Status Report on April 16, 2012.
4. The Parties would like to continue that discussion and exchange of information and hereby seek a two week extension to come to a mutual resolution and will file a status report or request to establish a procedural schedule on or before May 15, 2012, rather than wait until the previously ordered June 1, 2012 timeline.

5. The undersigned counsel has obtained permission to file this *Second Joint Status Report* by counsel for Lincoln County and Public Counsel.

WHEREFORE, Staff respectfully submits this *Second Joint Status Report* to the Commission for its information and consideration, and respectfully requests that the Commission grant until May 15, 2012, for the Parties to file a status report or proposed procedural schedule in this matter and any other relief that it deems just.
