**MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE
AUTHORITY AND ACCOMPANYING TARIFF**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and requests that the Commission cancel the certificate of service authority and accompanying tariff of TDI Communications, Inc. In support of its motion, Staff respectfully states as follows:

1. On December 14, 2001, the Missouri Public Service Commission (Commission) granted certificate of service authority to provide interexchange telecommunications service to TDI Communications, Inc. in Case No. TA-2002-212. The company's tariff, P.S.C. MO NO. 1, was approved in the same case.

2. TDI Communications, Inc. has now requested the Commission to withdraw its certificate of service authority. The letter from the company, co-signed by the president of the company, is attached as Attachment A. The company indicates that it has not offered telecommunications services and has not had any customers.

3. TDI Communications, Inc. owes no assessments or annual reports. No customers have contacted the Commission with complaints about TDI Communications, Inc. since the commencement of the Commission's EFIS system.

4. The Commission has the authority to cancel a telecommunications company certificate pursuant to Section 392.410.5 RSMo. (Supp. 2004), which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo.App. 1989).

5. Staff is serving this pleading upon the address provided by the company to the Commission; upon the counsel for the company; and upon the company's registered agent.

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority of TDI Communications, Inc. to provide interexchange telecommunications service and the company's tariff, P.S.C. MO NO. 1.
