ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: September 20, 2007 Effective Date: September 30, 2007

On June 22, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of PromiseVision Technology, Inc., a company that has been authorized to offer interexchange telecommunications services by the Commission.

In Case Number TA-2000-545, the Commission granted PromiseVision a certificate to provide interexchange telecommunications services.

PromiseVision's tariff, P.S.C. MO Tariff No. 1, was also approved.

Staff's motion states that they attempted numerous times to contact the company via various phone numbers and mail sent to the address provided to the Commission by the company. Carl Thompson, who is the individual who submitted the most recent annual report, indicated via a return phone call to Staff that PromiseVision is no longer operational. In addition, PromiseVision failed to file its annual registration report according to the Missouri Secretary of State's

Office, and its authorization to do business in the State of Missouri was revoked on February 19, 2004. No Complaints have been filed against PromiseVision since the commencement of the Electronic Filing and Information System. In addition, annual reports submitted to the Commission by PromiseVision covering calendar years 2002 through 2005 reflect decreasing telecommunications revenues. PromiseVision has not submitted its 2006 annual report or a fiscal year 2008 statement of revenue to the Commission. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, P.S.C. MO Tariff No. 1, to provide interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, because the company cannot be contacted and because the company no longer has the authority to conduct business in Missouri, the Commission finds that the certificate of service authority and accompanying tariff granted to PromiseVision Technology, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to PromiseVision Technology, Inc., in Case Number TA-2000-545, is canceled.

- 2. PromiseVision Technology, Inc.'s tariff, P.S.C. MO Tariff No. 1, is canceled.
 - 3. This order shall become effective on September 30, 2007.
 - 4. This case may be closed on October 1, 2007.
